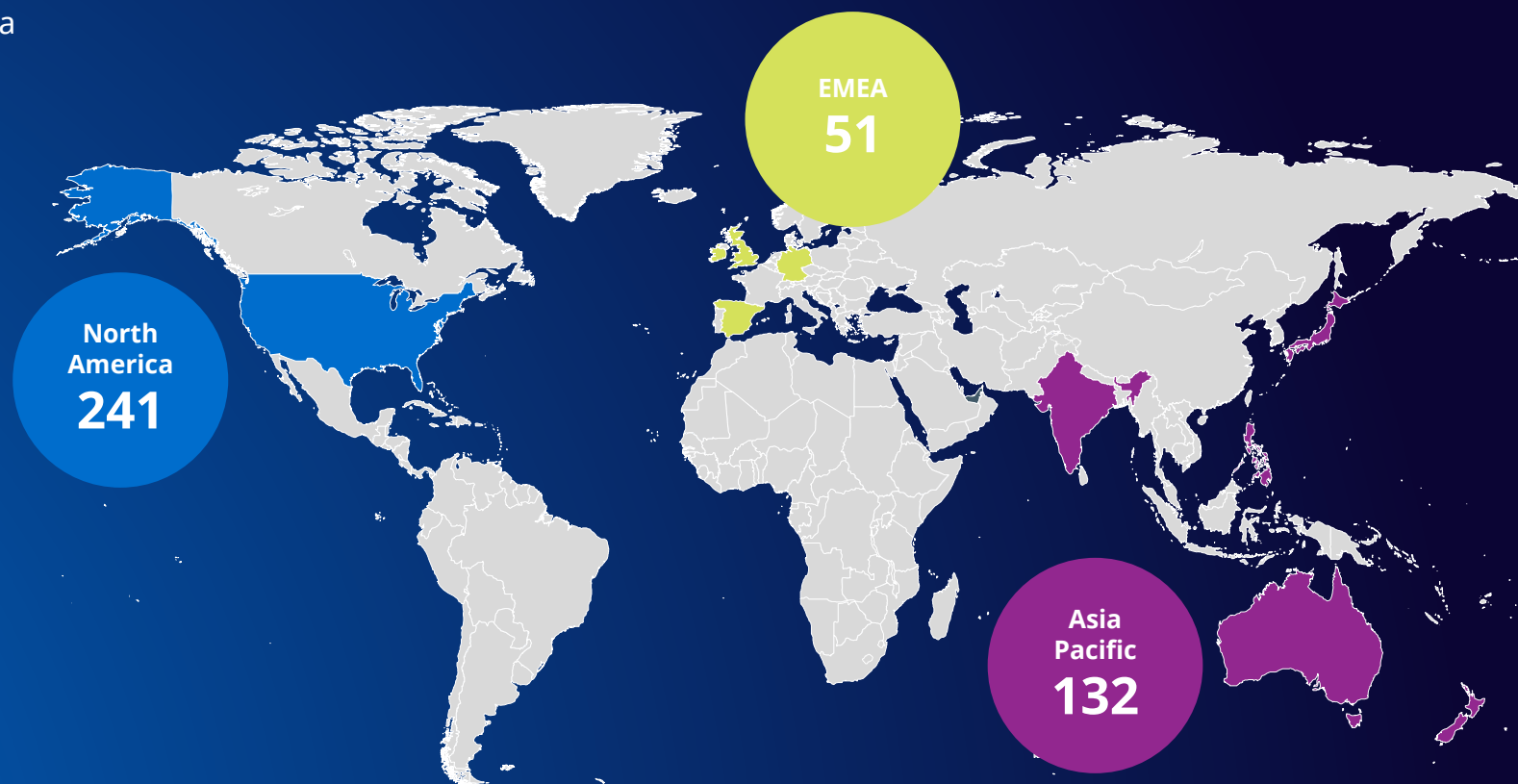





Nearly 400 children rescued and 348 adults arrested in Canadian child pornography bust

Nearly 400 children have been rescued and 348 adults arrested following an expansive and "extraordinary" international child pornography investigation, Canadian police announced Thursday.

The three-year project, named Project Spade, began when undercover officers with the Toronto Police Service Child Exploitation service made contact with a Toronto man allegedly sharing "very graphic images" of child sexual abuse in Oct. 2010. Toronto Police Service Chief William Blair said at a press conference on Thursday.

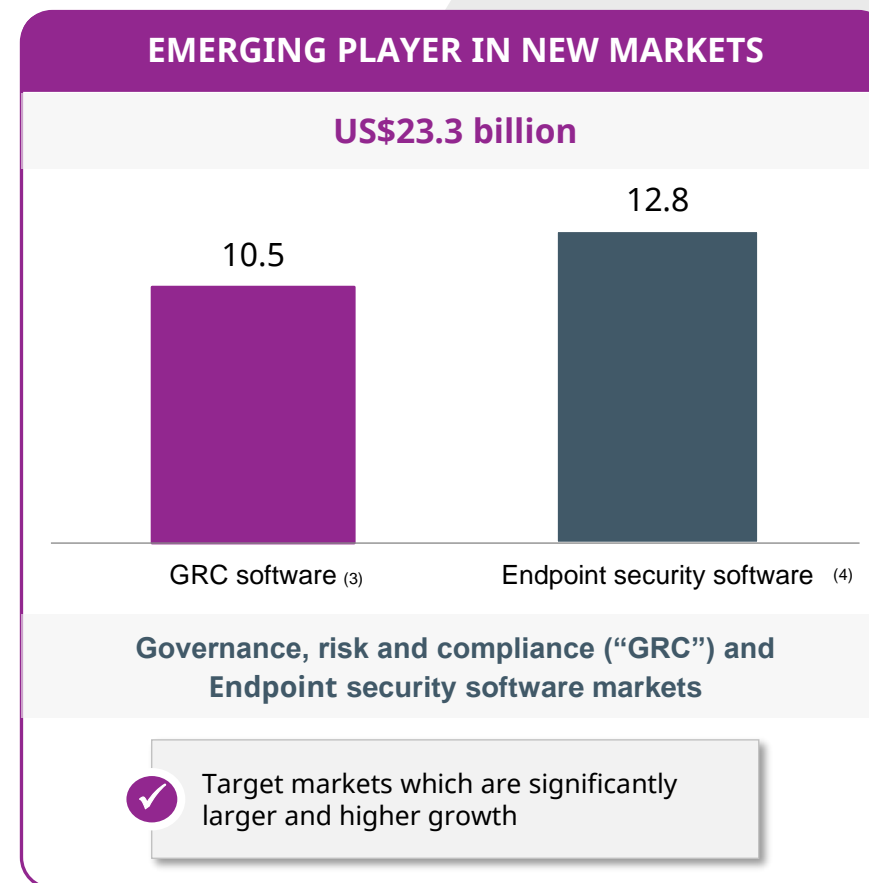
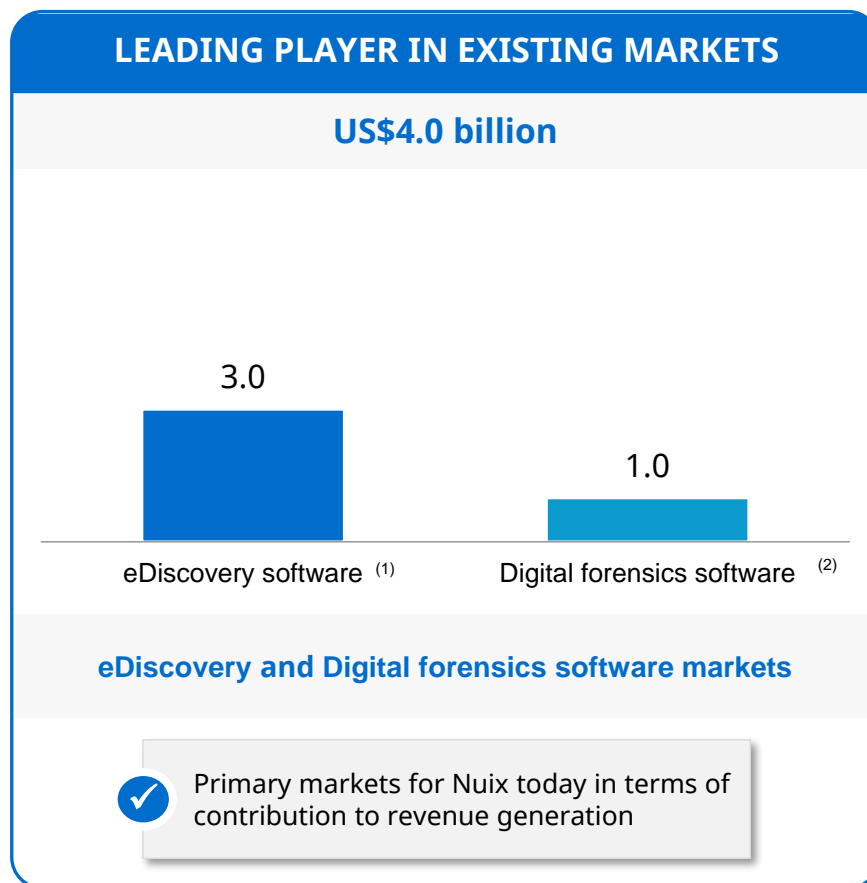


Increasing levels of digitisation and automation

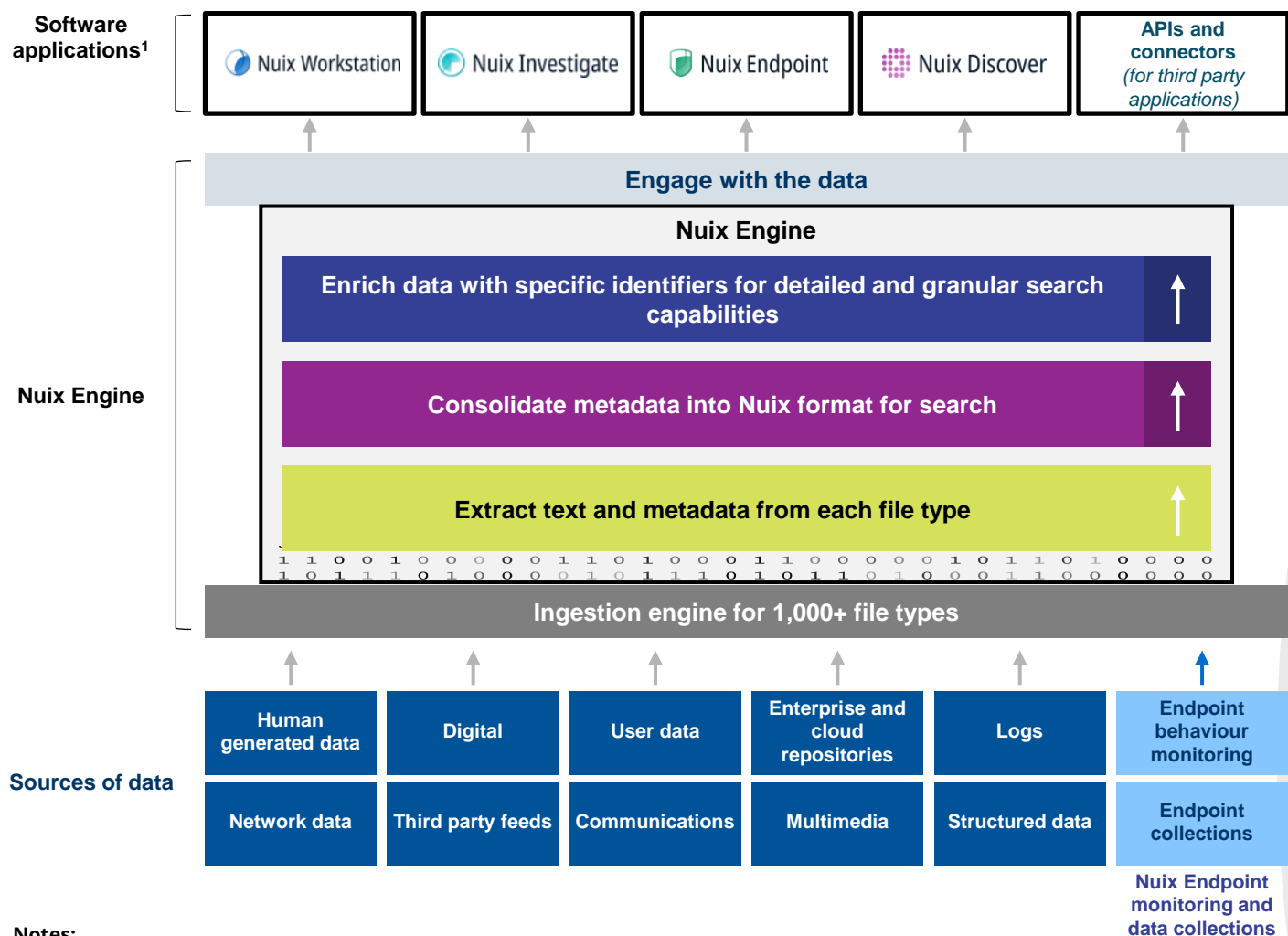

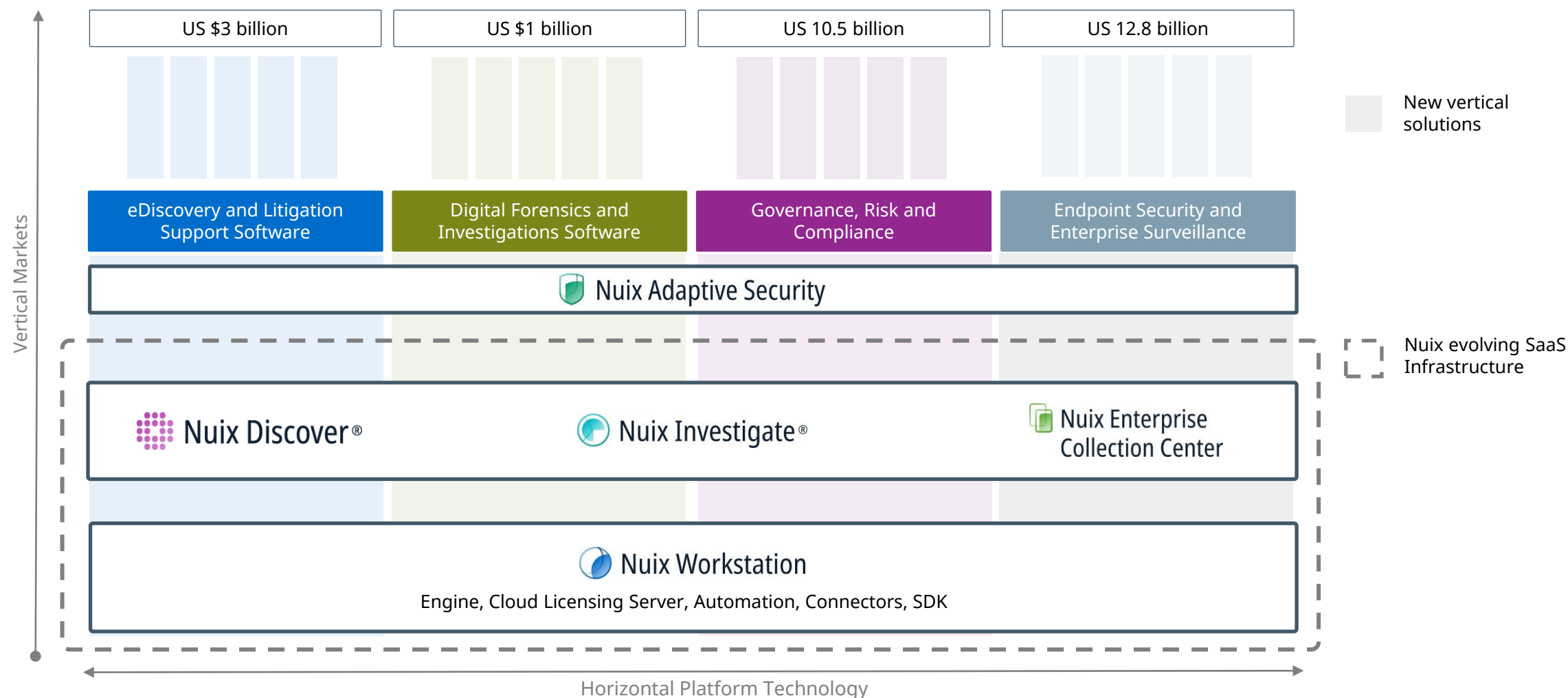

Business Model

Nuix is a software company with a sticky customer base and high recurring revenue.

Revenue consists of

- Subscription licenses 89%
- Perpetual licenses 7%
- Other (services and hardware) 4%

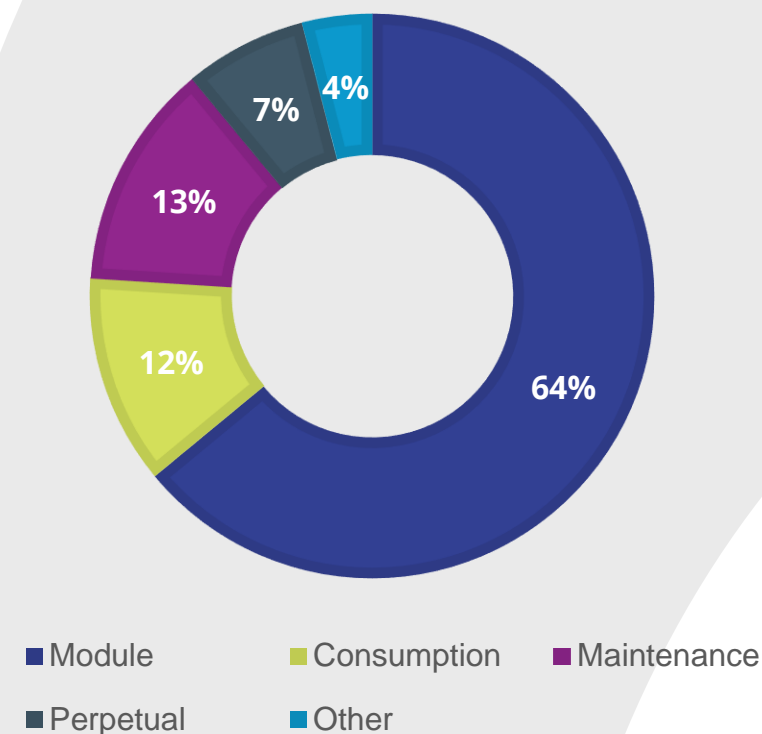
Nuix offers customers **flexible licensing options** to buy and access the software – whether it's cost per module (processing core, user or endpoint), cost per gigabyte (consumption) or on a perpetual basis

- Sold through direct and indirect sales channels across two regional divisions – the Americas and International
- Partner network provides additional geographic reach and wraps services around Nuix software platform
- Multi-year deals 25% of FY20 revenue (23% in 1H FY21)
- Sticky customer base with low churn (4.2% in 1H FY21)

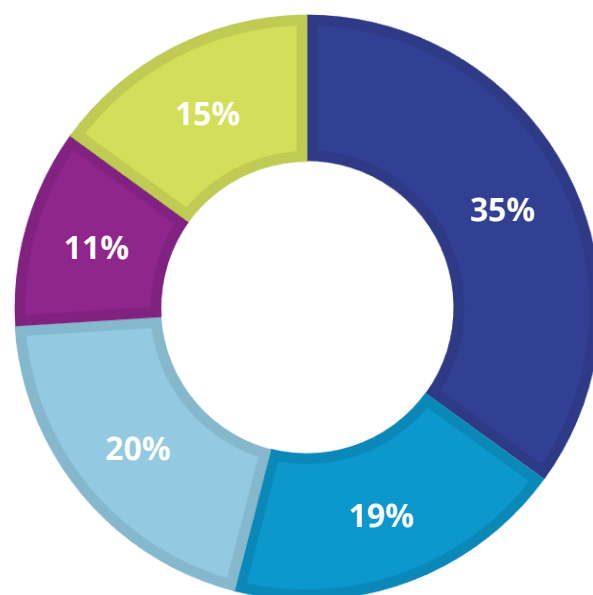
TOTAL REVENUE BY LICENSE (%)



Diversified Revenue

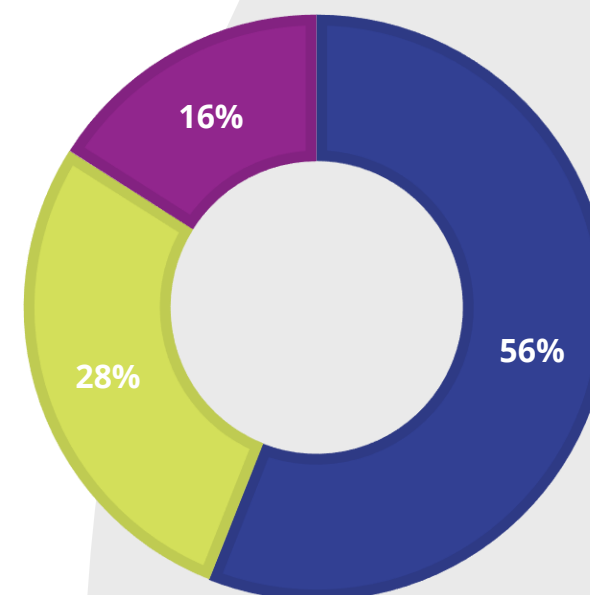
Blue chip customer base, well diversified by both segment and region
