	<b>Senior Secured Facility:</b> the company has a US\$7.5 million debt facility (US\$6.5m loan availability) with Macquarie Bank Limited which matures in September 2024. The facility is supported by its gas production assets in the Appalachia region of the USA and carries an interest rate of US LIBOR+650bps.		
	Macquarie and Empire have entered into a waiver agreement or potential breaches of the financial covenants under the debt facility for all quarterly covenant tests until 31 December 2020 (inclusive).		
	<b>Economic Injury Disaster Loan (EIDL):</b> during the quarter, Empire's US\$552,600 Paycheck Protection Program (PPP) loan was forgiven to US\$10,000 representing the remaining EIDL component of the program. The EIDL was originated through PNC Bank, is fully repayable, carries a fixed interest margin of 1% per annum, matures in May 2022 and is unsecured and subordinated to the Senior Secured Facility.		
	As the forgiveness of the PPP was a non-cash transaction, the transaction is not reflected through Empire's cash flows.
