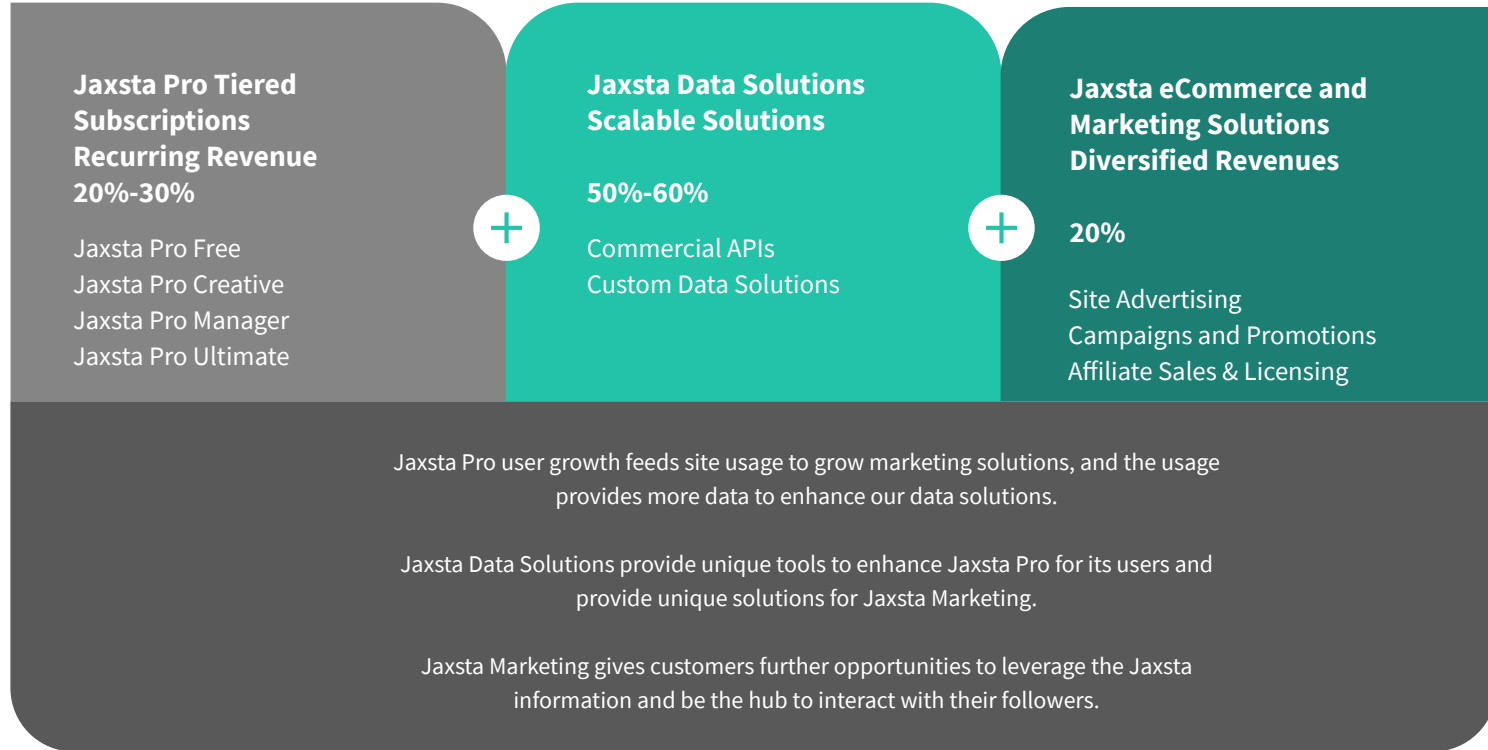

Application Program Interfaces (APIs) allow software programs to exchange information or request online services from an organisation by the use of organisation defined specifications or protocols.

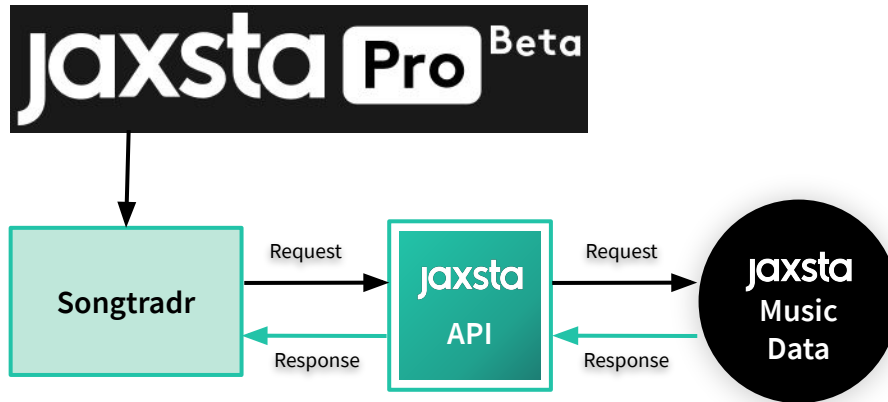


An example of the API being used in context

# Why Our API? Official Data Means...

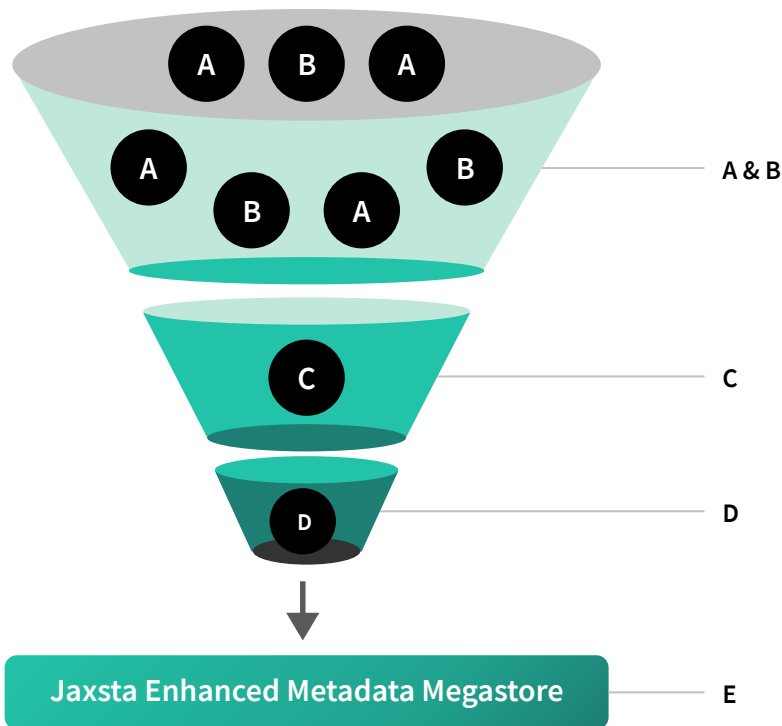

- Trusted data - we have the official data from the source
- Jaxsta cleans and matches the data it receives in order to deliver consistent and accurate data for the user
- Our data is not crowd sourced, with unknown validation
- **Our platform allows for collaboration with our partners - we're always working together on the collective metadata mission**
- Our data is diverse - from our list of partners, some of which are shown here, we receive over 1 million labels through 235K official data sources and we act independently to join the official data silos

Official data = Jaxsta *'the platform of choice'*



# Enhanced Source In A Competitive Environment



- A. Jaxsta also combines multiple sources, providing more than single source metadata (labels, charts, lyrics, publishing, news, awards etc)
- B. We add additional information collected from our other Jaxsta services
- C. The data within Jaxsta is been cleaned and linked using our advanced proprietary software to provide more manageable and usable data to our users and API clients
- D. We enhance data through Jaxsta initiated data science (unique views and links across data sources)
- E. The collective data sources above are cross matched to provide a single source of comprehensive data
