### Chief Geologist and Exploration Manager - Issue of Options

Resources and Energy Group Limited (ASX: REZ) advises it has issued 15,000,000 options to Mr Michael Johnstone (Mike), Chief Geologist and Exploration Manager of REZ. The options vest based on Mike continuing work with REZ, 50% vest in 12 months and thereafter on the 30 day VWAP for REZ shares being at or above 15c or in 24 months. Mike is now leading the exploration and development work across the East Menzies and Mount Mackenzie prospects.

The key terms of the options are set out below:

**Tranche 1:** 7,500,000 options to acquire an ordinary share exercisable at 5c on or before 30/9/25 which vest 12 months after issue subject to continuing engagement with REZ.

**Tranche 2:** 7,500,000 options to acquire an ordinary share exercisable at 5c on or before 30/9/25 which vest 24 months after issue subject to continuing engagement with REZ., or shall vest at any time after 12 months from issue if REZ ordinary shares have a volume weighted average price over any 30 day period at or above 15 cents.
