Completion of Rights Issue Shortfall Placement

UUV Aquabotix Ltd (ASX:UUV and UUVOA) (the "Company") is pleased to announce the successful placement of the shortfall from its recent Rights Issue (Refer ASX Releases 25 June 2020 and 24 July 2020).
