| <p>The loan from Aquis Finance Pty Ltd has a facility limit of \$4.934 million is secured and from 10 February 2020 attracts interest at 5% pa. On 31 January 2020, the Company announced that it had agreed with its financier Aquis Finance Pty Ltd to extend the current loan facility to 30 June 2022 and to provide an additional \$500,000 to assist funding current operations. Aquis Finance also requested that a variation document be completed to allow for them to convert the debt to equity in the company at \$0.02 per share.</p> <p>The \$157,500 loan comprises a short-term facility from a sophisticated investor. The facility was repayable on 13 January 2020 but has been extended by mutual consent.</p> |   |  |

- Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: The high level of cash expenditure during the period resulted from the reduction in outstanding expenses. The company has flexibility in applying its remaining funds to operations and so will be able to continue for a further 2 quarters. With restrictions resulting from COVID – 19, minimal new expenditure is being incurred.

- Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The company has substantial capacity to raise funds quickly under both Listing Rules 7.1 and 7.2. Based on their previous experience and success in raising capital and loan funds, the Directors are confident that the required additional funds can be obtained.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes – refer Q2 above. In addition, the company has held discussions with its financier Aquis Finance with respect to the provision of additional exploration finance once operations can resume.
