Financial statements and reports

To receive and consider the Company's annual financial report, including the directors' report and audit report for the year ended 30 June 2018.

Resolution 1: Adoption of Remuneration report

To consider, and if thought fit, to pass the following resolution as an **ordinary resolution**:

"That the Company adopt the remuneration report for the year ended 30 June 2018 in accordance with Section 250R(2) of the Corporations Act."

Notes:

The vote on this resolution is advisory only and does not bind the Directors or the Company.

Voting Exclusion Statement: The Company will disregard any votes cast on this Resolution 1 by or on behalf of a member of the Company's Key Management Personnel (KMP) whose remuneration details are disclosed in the Remuneration Report, or by or on behalf of a closely related party of a member of the KMP, in any capacity unless the vote is cast:

- by a person as proxy for a person who is entitled to vote, in accordance with the directions on the proxy form; or
- it is cast by the person chairing the Meeting as proxy for a person who is entitled to vote, in accordance with a direction on the proxy form to vote as the proxy decides.

The Chairman will vote all undirected proxies in favour of this resolution.

Resolution 2. Re-election of Gabriel Radzynski as a Director

To consider, and if thought fit, to pass the following resolution as an **ordinary resolution**:

"That Gabriel Radzynski, who retires by rotation in accordance with the Company's constitution and, being eligible for re-election, be re-elected as a Director."

Note: Without limitation, Rules 19.1, 19.2 and 19.3 of the Company's constitution are relevant to this resolution.

Resolution 3: Re-election of Daniel Weiss as a Director

To consider, and if thought fit, to pass the following resolution as an **ordinary resolution**:

“That Daniel Weiss, who retires by rotation in accordance with the Company’s constitution and, being eligible for re-election, be re-elected as a Director.”

- (a) by a person as proxy for a person who is entitled to vote, in accordance with the directions on the proxy form; or
- (b) it is cast by the person chairing the Meeting as proxy for a person who is entitled to vote, in accordance with a direction on the proxy form to vote as the proxy decides.

However, the entity need not disregard a vote if:

- It is cast by a person as proxy for a person who is entitled to vote, in accordance with the directions on the proxy form; or
- It is cast by the person chairing the Meeting as proxy for a person who is entitled to vote, in accordance with a direction on the proxy form to vote as the proxy decides.

The Chairman intends to vote all available undirected proxies in favour of this Resolution 5.

Resolution 5: Approval of issue of 13,250,000 2018 options to Gabriel Radzyninski

To consider and if thought fit, pass the following resolution as an **ordinary resolution**:

“That for the purposes of Listing Rule 10.11 and for all other purposes, Shareholders approve and authorise the Company to issue up to 13,250,000 options on the terms set out in the Explanatory Memorandum, to Mr Gabriel Radzyninski, or his nominees.”

Voting Exclusion Statement: The Company will disregard any votes cast in favour of Resolution 5 by or on behalf of Gabriel Radzyninski or any of his Associates, unless the vote is cast:

- (c) by a person as proxy for a person who is entitled to vote, in accordance with the directions on the proxy form; or
- (d) it is cast by the person chairing the Meeting as proxy for a person who is entitled to vote, in accordance with a direction on the proxy form to vote as the proxy decides.

However, the entity need not disregard a vote if:

- It is cast by a person as proxy for a person who is entitled to vote, in accordance with the directions on the proxy form; or
- It is cast by the person chairing the Meeting as proxy for a person who is entitled to vote, in accordance with a direction on the proxy form to vote as the proxy decides.

The Chairman intends to vote all available undirected proxies in favour of this Resolution 5.

Resolution 6: Approval of 10% Placement Facility

To consider and if thought fit, pass the following resolution as a **special resolution**:

“That for the purposes of Listing Rule 7.1A, the Directors are authorised to issue up to 10% of the Company's share capital calculated in accordance with Listing Rule 7.1A and otherwise on the terms and conditions set out in the Explanatory Memorandum attached.”

Without limitation, Listing Rule 7.1A is relevant to this resolution.

Voting Exclusion Statement: The Company will disregard any votes cast on this Resolution 6 by a person who is expected to participate in, or who will obtain a material benefit as a result of, the proposed issue (except a benefit solely by reason of being a holder of ordinary securities in the Company) if Resolution 6 is passed or any of their associates, unless the vote is cast:

- by a person as proxy for a person who is entitled to vote, in accordance with the directions on the proxy form; or
- it is cast by the person chairing the Meeting as proxy for a person who is entitled to vote, in accordance with a direction on the proxy form to vote as the proxy decides.

An Explanatory Memorandum accompanies and forms part of this notice of annual general meeting.

All Shareholders should read the Explanatory Memorandum carefully and in its entirety. Shareholders who are in doubt regarding any part of the business of the Meeting should consult their financial or legal adviser for assistance.

Voting by proxy

Any Shareholder entitled to attend and vote at this Meeting is entitled to appoint a proxy to attend and vote instead of that Shareholder.

The proxy does not need to be a Shareholder of the Company.

A Shareholder who is entitled to cast 2 or more votes may appoint 2 proxies and may specify the proportion or number of votes each proxy is appointed to exercise. If no proportion or number is specified, each proxy may exercise half of the Shareholder's votes.

Explanatory Memorandum

This Explanatory Memorandum sets out further information regarding the proposed resolutions to be considered by Shareholders of Mercantile Investment Company Limited (**Mercantile**) at the 2018 annual general meeting to be held commencing at 11.30 am (AEDT) on 31 October 2018 at the Sydney Harbour Marriott, May Gibbs Room, Level 2, 30 Pitt Street, Sydney NSW 2000.

The Directors recommend that Shareholders read this Explanatory Memorandum before determining whether or not to support the resolutions.

Financial statements and reports

Under Section 317 of the Corporations Act, Mercantile is required to lay its annual financial report, directors' report and remuneration report before its Shareholders at its annual general meeting. The annual financial report is submitted for Shareholders' consideration and discussion at the annual general meeting as required. Meeting attendees are invited to direct questions to the Chairman in respect of any aspect of the report they wish to discuss.

Representatives of Mercantile's auditor, Pitcher Partners, will be present for discussion purposes on matters of relevance to the audit.

Resolution 1: Adoption of Remuneration report

Resolution 1 provides Shareholders the opportunity to vote on Mercantile's remuneration report. The remuneration report is contained in the directors' report. Under Section 250R(2) of the Corporations Act, Mercantile must put the adoption of its remuneration report to a vote at its annual general meeting.

This vote is advisory only and does not bind the Directors or Mercantile.

The Board will consider the outcome of the vote and comments made by Shareholders on the remuneration report at this Meeting when reviewing Mercantile's remuneration policies. If 25% or more of the votes that are cast are voted against the adoption of the remuneration report at two consecutive annual general meetings, Shareholders will be required to vote at the second of those annual general meetings on a resolution (a "spill resolution") that another meeting be held within 90 days at which all of Mercantile's directors other than the managing director must be offered up for election.

Key Management Personnel (including Directors) and their closely related parties must not cast a vote on the remuneration report, unless as holders of directed proxies for Shareholders eligible to vote on Resolution 1.

Mercantile encourages all Shareholders to cast their votes on this resolution. The Chairman will vote all undirected proxies in favour of this resolution. If you wish to vote "against" or "abstain" you should mark the relevant box in the attached proxy form.

Board recommendation and undirected proxies. The Board recommends that Shareholders vote in **FAVOUR** of resolution 1. The Chairman of the Meeting intends to vote undirected proxies in **FAVOUR** of resolution 1.

Resolution 2: Re-election of Mr Gabriel Radzynski as a Director

Under Rule 19.1 of Mercantile's constitution and Listing Rule 14.4 a director must not hold office (without re-election) past the third annual general meeting following the director's appointment. Mr Gabriel Radzynski was last elected in 2015.

Under Rule 19.2 of Mercantile's constitution one third of Mercantile's Directors, or the whole number nearest to one third, must retire unless re-elected.

Resolution 2 provides for the re-election of Mr Gabriel Radzynski as Director of Mercantile in accordance with Rule 19.1 & 19.3 of Mercantile's constitution.

The Directors (excluding Mr Gabriel Radzynski) unanimously recommend that Shareholders vote in favour of Resolution 2.

Board recommendation and undirected proxies. The Board recommends that Shareholders vote in **FAVOUR** of resolution 2. The Chairman of the Meeting for this item of business intends to vote undirected proxies in **FAVOUR** of resolution 2.

Resolution 3: Re-election of Mr Daniel Weiss as a Director

Under Rule 19.1 of Mercantile's constitution and Listing Rule 14.4 a director must not hold office (without re-election) past the third annual general meeting following the director's appointment. Mr Daniel Weiss was last elected in 2015.

Under Rule 19.2 of Mercantile's constitution one third of Mercantile's Directors, or the whole number nearest to one third, must retire unless re-elected.

Resolution 3 provides for the re-election of Mr Daniel Weiss as Director of Mercantile in accordance with Rule 19.1 & 19.3 of Mercantile's constitution.

The Directors (excluding Mr Daniel Weiss) unanimously recommend that Shareholders vote in favour of Resolution 3.

Board recommendation and undirected proxies. The Board recommends that Shareholders vote in **FAVOUR** of resolution 3. The Chairman of the Meeting for this item of business intends to vote undirected proxies in **FAVOUR** of resolution 3.

Resolution 4: Approval of issue of 10,000,000 2017 options to Gabriel Radzynski

This resolution seeks Shareholder approval for the proposed issue of **10,000,000** 2017 options in the Company to Gabriel Radzynski, for the purposes of Listing Rule 10.11. Listing Rule 10.11 requires the Company to obtain Shareholder approval in order to grant equity securities to a related party (which includes a director) unless an exception applies.

In accordance with ASX Listing Rule 10.13, the following information is provided to Shareholders for the purpose of obtaining Shareholder approval of Resolutions.

The purpose of the grant of these options to Mr Radzynski is for the Company to appropriately incentivise and provide cost effective remuneration for his ongoing commitment and contribution to the Company via Sandon Capital Pty Ltd, which has a management agreement with the Company.

The Board does not consider that there are any significant opportunity costs to the Company or benefits foregone by the Company in issuing the options upon the terms proposed. If the options are not granted, the Company could remunerate Mr Radzynski with additional cash. However, the Board considers it reasonable for the remuneration of Mr Radzynski to have an equity component to further align Mr Radzynski's interests with Shareholders and maintain a strong cash position for the Company. The Company seeks to issue a maximum of 10,000,000 2017 options to Mr Radzynski for nil consideration. As announced to ASX on 6 December 2017, the Board resolved to grant 10,000,000 options to Mr Radzynski subject to shareholder approval at the next general meeting.

Each 2017 option entitles the holder to subscribe for one fully paid ordinary share in the capital of the Company at the exercise price any time before the expiry date listed below:

The funds raised will enable Mercantile to continue to pursue the strategy outlined above by selectively investing in share market opportunities that the Directors consider offer the prospect for attractive risk-adjusted returns.

If resolution 4 is passed, the 2017 options will be issued as soon as practicable following Shareholder approval, and in any event, not more than one month following the date of the annual general meeting.

If approval is given under Listing Rule 10.11, separate approval is not required under Listing Rule 7.1. Accordingly, if this resolution is approved, the issue of 2017 options will not be included in the 15% calculation for the purposes of Listing Rule 7.1.

Gabriel Radzynski and his closely related parties must not cast a vote on the issue of options, unless as holders of directed proxies for Shareholders eligible to vote on Resolution 4.

Board recommendation and undirected proxies. The Board recommends that Shareholders vote in **FAVOUR** of resolution 4. The Chairman of the Meeting intends to vote undirected proxies in **FAVOUR** of resolution 4.

Resolution 5: Approval of issue of 13,250,000 2018 options to Gabriel Radzynski

This resolution seeks Shareholder approval for the proposed issue of options in the Company to Gabriel Radzynski, for the purposes of Listing Rule 10.11. Listing Rule 10.11 requires the Company to obtain Shareholder approval in order to grant equity securities to a related party (which includes a director) unless an exception applies.

In accordance with ASX Listing Rule 10.13, the following information is provided to Shareholders for the purpose of obtaining Shareholder approval of Resolutions.

The purpose of the grant of these options to Mr Radzynski is for the Company to appropriately incentivise and provide cost effective remuneration for his ongoing commitment and contribution to the Company via Sandon Capital Pty Ltd, which has a management agreement with the Company.

The Board does not consider that there are any significant opportunity costs to the Company or benefits foregone by the Company in issuing the options upon the terms proposed. If the options are not granted, the Company could remunerate Mr Radzynski with additional cash. *The exercise price will be reduced by the value of any dividends paid by Mercantile to shareholders, if any, after the date of issue of the 2018 options but prior to the date of exercise.

The funds raised will enable Mercantile to continue to pursue the strategy outlined above by selectively investing in share market opportunities that the Directors consider offer the prospect for attractive risk-adjusted returns.

If resolution 5 is passed, the 2018 options will be issued as soon as practicable following Shareholder approval, and in any event, not more than one month following the date of the annual general meeting.

If approval is given under Listing Rule 10.11, separate approval is not required under Listing Rule 7.1. Accordingly, if this resolution is approved, the issue of 2018 options will not be included in the 15% calculation for the purposes of Listing Rule 7.1.

Gabriel Radzynski and his closely related parties must not cast a vote on the issue of options, unless as holders of directed proxies for Shareholders eligible to vote on Resolution 5.

Board recommendation and undirected proxies. The Board recommends that Shareholders vote in **FAVOUR** of resolution 5. The Chairman of the Meeting intends to vote undirected proxies in **FAVOUR** of resolution 5.

Resolution 6: Approval of 10% Placement Facility

Listing Rule 7.1A provides that an eligible entity may seek Shareholder approval by special resolution at its annual general meeting to issue equity securities equivalent to an additional 10% of the number of ordinary securities on issue over a period of 12 months after the annual general meeting (10% Placement Capacity). This is in addition to the existing 15% placement capacity permitted by Listing Rule 7.1.

If Shareholders approve Resolution 6, the number of equity securities the Company may issue under the 10% Placement Capacity will be determined in accordance with the formula prescribed in Listing Rule 7.1A.2 (as set out below).

An eligible entity is one that, as at the date of the relevant annual general meeting:

- is not included in the S&P/ASX 300 Index; and
- has a maximum market capitalisation (excluding restricted securities and securities quoted on a deferred settlement basis) of \$300,000,000.

The Company is an eligible entity as it is not included in the S&P/ASX 300 Index and has a current market capitalisation of less than \$300,000,000.

Any equity securities issued under Listing Rule 7.1A must be in the same class as an existing class of quoted equity securities. The Company currently has two classes of quoted securities on issue, being Shares (ASX Code: MVT) and Notes (ASX Code: MVTHA).

The number of equity securities that the Company may issue under the approval sought by Resolution 3 will be calculated in accordance with the following formula as set out in Listing Rule 7.1A.2:

(A x D) – E

Where:

A = the number of fully paid Shares on issue 12 months before the date of issue or agreement to issue:

plus the number of Shares issued in the 12 months under an exception in Listing Rule 7.2;

plus the number of partly paid Shares that became fully paid in the 12 months;

plus the number of fully paid Shares issued in the 12 months under Listing Rules 7.1 or 7.4; and

less the number of fully paid Shares cancelled in the 12 months.

D = 10%.

E = the number of equity securities issued or agreed to be issued under Listing Rule 7.1A.2 in the 12 months before the date of issue or agreement to issue that are not issued with the approval of the Shareholders under Listing Rule 7.1 or 7.4.

Technical information required by Listing Rule 7.3A

While the Company does not have any immediate plans to issue equity securities, purposes for which equity securities may be issued pursuant to Resolution 6 may include the raising of capital to facilitate further investment opportunities.

Pursuant to and in accordance with Listing Rule 7.3A, the information below is provided in relation to Resolution 6:

- (a) **Minimum Price:** Under the Listing Rules, the minimum price at which the equity securities may be issued is 75% of the volume weighted average market price of equity securities in that class, calculated over the 15 trading days on which trades in that class were recorded immediately before:
- i. the date on which the price at which the equity securities are to be issued is agreed; or
 - ii. if the equity securities are not issued within 5 trading days of the date in paragraph (i) above, the date on which the equity securities are issued.
- (b) **Risk of voting dilution:** Shareholders should be aware there is a risk of economic and voting dilution that may result from an issue of equity securities under the 10% Placement Capacity, including the risk that:
- i. the market price for equity securities in that class may be significantly lower on the issue date than on the date of the annual general meeting where approval is being sought; and
 - ii. the equity securities may be issued at a price that is at a discount to the market price for those equity securities on the date of issue.

Any issue of equity securities under the 10% Placement Capacity will dilute the interests of Shareholders who do not receive any equity securities under the issue, unless the only equity securities issued under the 10% Placement Capacity are options and these options are not exercised.

If Resolution 6 is approved by Shareholders and the Company issues the maximum number of equity securities available under the 10% Placement Capacity, the economic and voting dilution of existing Shares would be as shown in the table below, assuming that any options issued under the 10% Placement Capacity are exercised.

The table below shows the potential dilution of existing Shareholders calculated in accordance with the formula outlined in Listing Rule 7.1A.2, on the basis of the current market price of the Shares and the current number of Shares on issue as at the date of this notice of meeting. The table also assumes that no options on issue are exercised into Shares before the date of issue of the equity securities.

The table also shows the voting dilution impact where the number of Shares on issue (variable A in the formula) changes and the economic dilution where there are changes in the issue price of Shares issued under the 10% Placement Capacity.

The table has been prepared on the following assumptions:

- (i) The Company issues the maximum number of shares available under Listing Rule 7.1A;

- (ii) No Shares are issued on the conversion of options before the date of issue of the Shares;
- (iii) The table shows only the effect of Shares issues under Listing Rule 7.1A and does not factor in the Company's ability to issue up to 15% of its issued capital under Listing Rule 7.1; and
- (iv) The issue price is \$0.17, being the closing price of the Shares on ASX on 12 September 2018.

The table shows:

- two examples where variable "A" has increased, by 50% and 100%. Variable "A" is based on the number of Shares the Company has on issue. The number of Shares on issue may increase as a result of issues of Shares that do not require approval (for example, a pro rata entitlements issue) or future specific placements under Listing Rule 7.1 that are approved at a future Shareholders' meeting; and
- two examples of where the issue price of Shares has decreased by 50% and increased by 100% as against the current market price.

- (c) **Date of Issue:** If Shareholder approval is granted for Resolution 6, then that approval will expire on the earlier of:

- 31 October 2019, being 12 months from the date of the Meeting; or
- the date Shareholder approval is granted to a transaction under Listing Rule 11.1.2 (proposed change to nature and scale of activities) or Listing Rule 11.2 (change involving main undertaking).

The approval under Listing Rule 7.1A will cease to be valid in the event that Shareholders approve a transaction under Listing Rule 11.1.2 or 11.2.

- (d) **Purpose of Issue under 10% Placement Capacity:** The Company may issue equity securities under the 10% Placement Capacity for the following purposes:

- as cash consideration in which case the Company intends to use funds raised for investment purposes in line with the Company's current investment policy; or
- as non-cash consideration for investments, in such circumstances the Company will provide a valuation of the non-cash consideration as required by Listing Rule 7.1A.3.

- (e) **Allocation under the 10% Placement Capacity:** The allottees of the equity securities to be issued under the 10% Placement Capacity have not yet been determined. However, the allottees of equity securities could consist of current security holders or new investors (or both), none of whom will be related parties of the Company.

The Company will determine the allottees at the time of the issue under the 10% Placement Capacity, having regard to the following factors:

- the purpose of the issue;
- alternative methods for raising funds available to the Company at that time, including, but not limited to, an entitlement issue or other offer where existing Shareholders may participate;
- the effect of the issue of the equity securities on the control of the Company;
- the circumstances of the Company, including, but not limited to, the financial position and solvency of the Company;
- prevailing market conditions; and
- advice from corporate, financial and broking advisers (if applicable).

- (f) **Previous Approval under Listing Rule 7.1A:** The Company obtained Shareholder approval under Listing Rule 7.1A at the 2017 annual general meeting held on 26 October 2017.
