# Abitibi Zone Continues to Deliver High-Grade Drilling Success

- **Drill Holes F-19-160 and F-19-166 delivered excellent results<sup>1</sup> that show continuity in the high-grade core at Abitibi, which remains open toward surface and at depth**
- **The Abitibi Zone continues to deliver High-Grade Zinc, together with potentially economic levels of copper, lead, gold and silver**
- **F-19-160: 3.75m @ 27.2% Zn, 0.4% Cu, 1.9% Pb, 0.7g/t Au, 442g/t Ag from 412.1m<sup>2</sup>**
- **F-19-166: 29.0m @ 5.4% Zn, 0.1% Cu, 0.9% Pb, 0.2g/t Au, 87g/t Ag from 389.5m<sup>2</sup>**

Odin Metals Limited (ASX: ODM) ("Odin" or "the Company") is pleased to announce the receipt of the further assays from the its maiden drill programme at the Sturgeon Lake Project<sup>3,4</sup> ("Project") in Ontario, Canada.

**Hole F-19-160 and F-19-166 returned high-grade results** equal or better to that returned earlier in F-19-158, which in turn is in line with previously reported historic results<sup>5</sup>. **Results improve continuity in the high-grade core, and which remains open at depth and to surface** (see Figure 1).

Long Section A-A' (Figure 1) shows the **updated interpretation of the broader Abitibi mineralised envelope (Upper Zone) which extends over approximately 1.5km of strike, and the high-grade core within this.**

Drilling in the maiden programme is complete, while results are still pending for three holes (see table of results). **Holes F-19-161, F-19-163 and F-19-165 also successfully intersected the Upper Zone mineralised envelope, outside of the high-grade core.**

**At Bell Lake West new and previously unrecognized prospective VMS trend has been found.** Ground reconnaissance over three strong VTEM anomalies at has identified outcropping prospective volcanic sediments and geology prospective for VMS mineralisation. **Outcrop contains visible sulphides, including visible chalcopyrite (copper)<sup>6</sup>.**

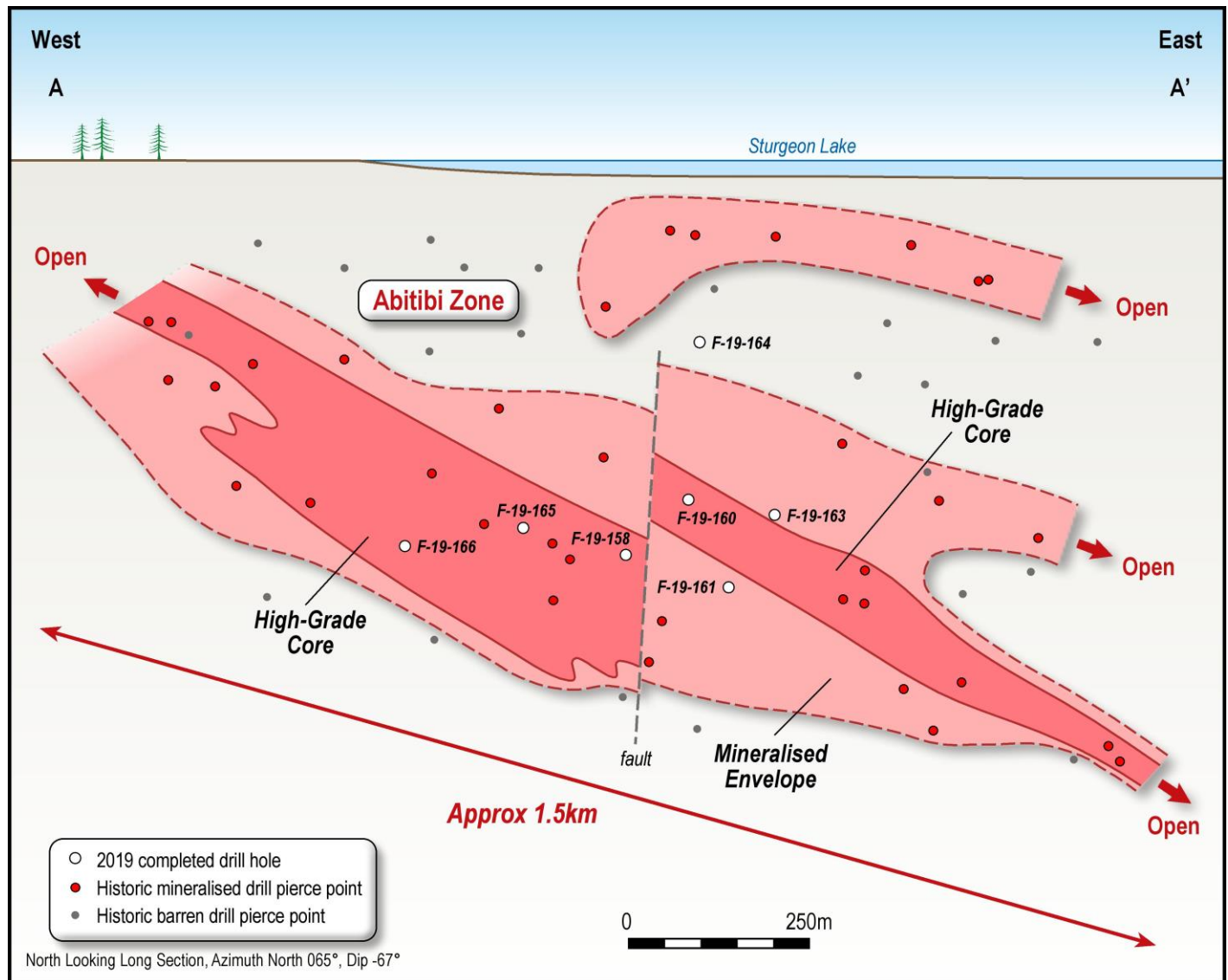

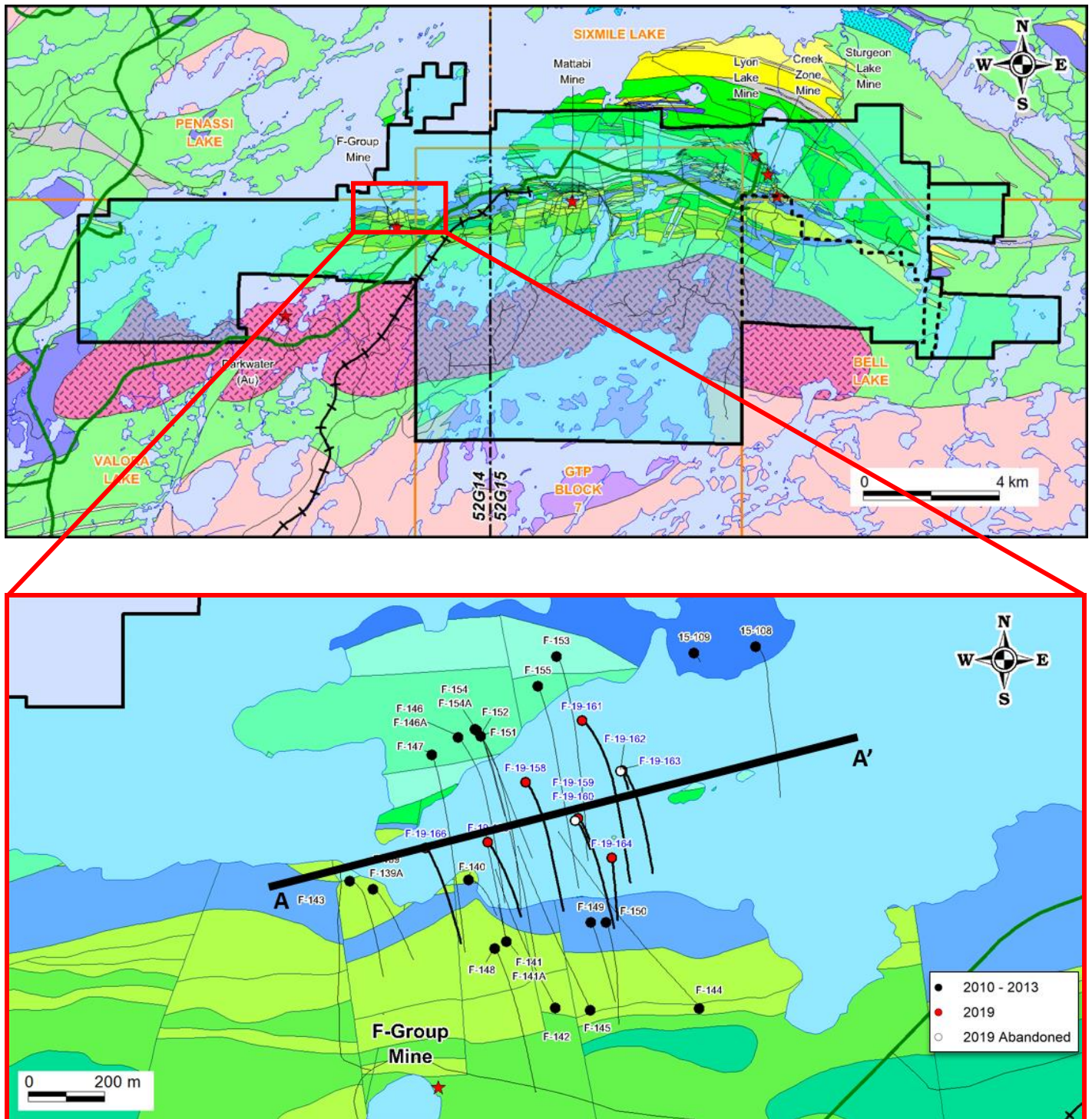


Work will now focus on interpretation and planning for the next exploration program in the first half of 2020. This will include any follow-up drilling at Abitibi, drill testing of the priority A2 VTEM target (a potential repetition or offset of the existing Abitibi Zone), and ground EM surveying at Bell Lake West in preparation for drill testing.
