APPENDIX 3B

Following approval of the Board of Directors, the Company has granted an aggregate of 61,000 options over common stock to multiple employees of the Company at a strike price at or near the ASX market price (in US Dollars).

The Company has also issued an aggregate of 17,500 new shares of common stock upon the exercising of vested stock options.

Options over 32,500 shares of common stock have failed to vest since the previously filed Appendix 3B.
