On 24 October 2017 the Company entered into a binding Term Sheet with Chan Investments Limited for a yet to be determined amount to reasonably cover the cost of; 1) the acquisition of the Union Extended (UE) Project; 2) the acquisition of a suitable relocatable gold processing plant of at least 450k tpa capacity; and 3) the MTP and UE security bonds payable to the NT Government.

No amounts have yet been drawn against this loan.

The agreed interest rate is 17% pa. Other terms and conditions including repayment conditions are yet to be determined.
