Notice under section 1012DA(5)(e) of the Corporations Act 2001 (Cth)

This notice is given by HCW Funds Management Limited (ACN 104 438 100) (**Responsible Entity**) as responsible entity of HealthCo Healthcare and Wellness REIT (ARSN 652 057 639) (**HCW**) under section 1012DA(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**).

As announced on 30 March 2023, the Responsible Entity undertook a placement of new fully paid ordinary units in HCW to wholesale clients and institutional investors in conjunction with an accelerated non-renounceable entitlement offer (**Capital Raising**). Subject to satisfying certain conditions, investors that participated in the Capital Raising are eligible to receive bonus fully paid ordinary units in HCW (**Bonus Units**). The Responsible Entity has completed the issue and allotment of a further 37,990 Bonus Units to eligible investors.

The Responsible Entity confirms the following:

- (a) the Bonus Units were issued without a product disclosure statement for the Bonus Units being prepared;
- (b) this notice is being given under section 1012DA(5)(e) of the Corporations Act;
- (c) as a disclosing entity, the Responsible Entity (as the issuer of the Bonus Units) is subject to regular reporting and disclosure obligations;
- (d) as at the date of this notice, the Responsible Entity has complied with:
 - (i) the provisions of Chapter 2M of the Corporations Act as they apply to HCW; and
 - (ii) sections 674 and 674A of the Corporations Act as they apply to HCW; and
- (e) as at the date of this notice, there is no excluded information of the type referred to in sections 1012DA(7) and 1012DA(8) of the Corporations Act.
