The Company is issuing shares to an institutional investor as it is considered to be a more certain and efficient mechanism for raising funds in the current market environment, and the shares are being issued at a premium to the current market price of shares. With a firm commitment received for the placement, the Company is not exposed to market volatility that it may have experienced over a more extended capital raising process such as a pro rata issue. The shares are being issued under existing placement capacity pursuant to LR 7.1A, the use of which was approved by shareholders at the last AGM
