This notice is given by Allegra Innovations Pty Ltd ACN 670 616 127 (**AI**) in respect of the offers dated 20 June 2024 made by AI under its off-market takeover bid to acquire all of the ordinary shares in AMT (**Offers**). The Offers are contained in AI's bidder's statement dated 19 June 2024 (as varied by the notices dated 10 July 2024, 24 July 2024 and 8 August 2024, and supplemented by the first supplementary bidder's statement dated 21 June 2024, second supplementary bidder's statement dated 1 July 2024, and third supplementary bidder's statement dated 8 August 2024) (**Bidder's Statement**). Unless the context requires otherwise, capitalised terms in this notice have the same meaning given to them in the Bidder's Statement.

AI hereby states, pursuant to section 630(3) of the *Corporations Act 2001* (Cth), that:

1. In the notice dated 10 July 2024 it declared that the condition in paragraph 4 (No Prescribed Occurrences between Announcement Date and service of Bidder's Statement) of Appendix 2 to the Bidder's Statement had been fulfilled so that the Offers became free of that Condition;
2. In the notice dated 8 August 2024 and third supplementary bidder's statement dated 8 August 2024, it declared the offers contained in its Bidder's Statement to be free from all remaining conditions contained in Appendix 2 of the Bidder's Statement; and
3. AI's voting power in AMT is 80.60%.
