### Cardno Limited (ASX: CDD) – Distribution to Shareholders and Shareholder update

The Board of Cardno Limited (ASX:CDD) ("**Cardno**") advises that it has determined to distribute an unfranked dividend of AUD \$3.9m (10.0 cents per share) to Cardno shareholders ("**Shareholders**") on the register of Cardno as at the record date (being 7:00pm (AEST) on Monday, 27 May 2024) ("**Record Date**") ("**Special Dividend**"). The Special Dividend will be paid on Monday, 24 June 2024.

This distribution reflects the receipt of dividends of US\$0.7m from Entrix Americas and the collection of the final balance (principal & interest) outstanding of \$3.7m from DT Global Australia Pty Ltd ("**DT Global**") related to the sale of Cardno International Development<sup>1</sup>. Prior to this distribution, the Head Office cash balance on 13 May 2024 was \$6.5m.

As noted in the previous announcement on 5 April 2024, the Cardno Board continues to focus on:

- the divestment of Entrix operations. Entrix is a US\$3m revenue socio-economic business operating in Ecuador and Peru;
- the collection of cash related to Insus legal claims. The current expectation is that in the next 12 months, the size of any potential collections will be less than US\$1m but is dependent on the progress of legal cases; and
- minimisation of head office and listed legal entity costs to enable the maximum amount of proceeds to be distributed to Shareholders. Head office and listed legal entity costs are currently run rating at \$1.2m p.a.

When the Board of Cardno believes that the cost of operating the listed entity outweigh the benefits of further collections, the Board of Cardno will consider options for the listed entity.

#### Distribution

Cardno has determined to distribute AUD \$3.9m (in aggregate) to Shareholders (10.0 cents per share) as at the Record Date as an unfranked dividend. The Special Dividend will be paid on Monday, 24 June 2024.
