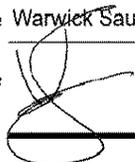

On 29 April 2024, ECL held an EGM at which was considered a resolution to wind-up ECL as put forward by various parties, including the party now lodging this form.

8,924,636 shares were voted in favour of winding up ECL. Excluding votes cast by ECL board members, each of whom continues to receive directors' fees whilst ECL still exists and they remain in those board positions, just 25,918 shares were voted against winding up ECL. However, the number of shares held by those directors and voted in favour of keeping ECL alive was sufficient to ensure ECL survives. Given that, the parties who proposed the wind-up resolution consider that their relevant association in relation to that resolution has now ended.
