CORPORATE GOVERNANCE STATEMENT

The Directors and Management of Wizr Limited (**Wizr** or the **Company**) are committed to conducting the business of Wizr and its controlled entities (the **Group**) in an ethical manner and in accordance with the highest standards of corporate governance. The Company reports against the *ASX Corporate Governance Principles and Recommendations (Fourth Edition)* (**Recommendations**) and substantially complies with the Recommendations, to the extent appropriate to the size, life cycle stage and nature of the Group's operations.

Consistent with the Company's commitment to transparency in its dealings with stakeholders, this Corporate Governance Statement (**Statement**) has been prepared in respect of the financial year ending on 30 June 2022 (**Reporting Period**) and by reference to each recommendation contained in the Recommendations. The Statement was approved by the Company's Board on 26 October 2022 and is current as at that date.

In this Statement, all references to the Company's website are to www.wizr.com.au (**Website**).

The Board is committed to maximising performance, generating appropriate levels of shareholder value and financial return, and sustaining the growth and success of Wizr. In conducting business with these objectives, the Board seeks to ensure that Wizr is properly managed to protect and enhance shareholder interests, and that Wizr and its directors, officers and personnel operate in an appropriate environment of corporate governance. Accordingly, the Board has created a framework for managing Wizr, including adopting relevant internal controls, risk management processes and corporate governance policies and practices which it believes are appropriate for Wizr's business and which are designed to promote the responsible management and conduct of the Company.
