

Answer: The company is finalising a new overdraft facility.
Additionally, there has been improvement in cash flow recorded subsequent to the end of the quarter. There are also plans for the commencement of a new business division.

Answer: Yes. The company is continuing to discuss new business opportunities which will enhance its cash position.
