SenSen AI Positioning – Live Awareness

SenSen empowers enterprises to have real-time awareness of their operations & customer activity.

We call this **Live Awareness**.

It's a class of AI that uses cameras and sensors to constantly monitor business activity (physical world) and interpret that activity within the context of the business rules (digital information) to improve operational efficiency and safety of businesses.


Some of the closest examples of Live Awareness AI include

- Self-Driving Cars: When a self-driving car stops because someone unexpectedly moves in front of the vehicle, that is Live Awareness in action; Similarly
- When a robot or a drone moves from one location to another delivering goods without bumping into anything or anyone on their way, it's Live Awareness in action.

The above examples illustrate the Live (real-time) awareness capabilities obtained from combining the sensor readings related to their surroundings and contexts to make decisions in real-time. However, they are limited to very narrow (focused on a specialist use case) or very broad (its value proposition is minimal to a specific use case)

SenSen designs its world Live Awareness platform that has similar capabilities of taking camera, GPS and lidar data like the self-driving cars or robots but focuses on solving enterprise operations problems. It is designed to be deployed anywhere and by any business to realise operational efficiencies.

Benefits of Live Awareness AI include increased efficiency, productivity and safety as well as reduced labour costs and improved customer service.




Financial Highlights

SenSen crossed in \$10M cash receipts, collecting \$11.2M in a financial year for the first time in its history. Previous high was \$8.8M in FY22. Collected \$3.3M in Q423 (slightly less than \$3.7M collected in Q422).


~27% YoY growth in customer cash-receipts against the backdrop of extremely turbulent economic conditions.

Demonstrates resilience of the business with a balanced mix of government and private enterprise customers.

Growing revenues while simultaneously reducing costs – leading towards cashflow positivity



Note: Green bars in chart above identify comparable quarters.



The multi-quarter moving average trend above clearly shows that the blue line (customer cash receipts) is getting closer to cross over the red (opex) and is poised to drive the company to cash-flow positive territory in FY2024.



Casino Gaming Update

SenSen has won new contracts worth over USD\$1M (~A\$1.53M) in this quarter that include:

- A new three-year US\$969k contract (~A\$1.44M) contract with a new Asian casino.
- A contract for a paid trial of US\$60k (~A\$89k) with an independent casino in Asia.

SenSen has further strengthened its gaming patent portfolio with the granting of the following five patents in the last six months and the portfolio now comprises three granted patent families in multiple countries. Protection in further countries for these patent families is ongoing.




