



Correction of Appendix 3X disclosures

Critical Minerals Group Limited (**ASX:CMG**) (**Critical Minerals Group, CMG or the Company**) advises corrections to the following previously released disclosures (**original disclosures**):

1. Appendix 3X released 12 December 2022; and
2. Appendix 3X released 25 November 2022.

The Initial Directors' Interests Notices (Appendix 3X) were incorrect due to a misclassification of certain holdings as notifiable interests. Notifiable interests are holdings for which the Director meaningfully controls the disposal and/or voting of the shares (or other securities) and do not necessarily include related party holdings unless they fall under this definition.

The details of the holders and the number of shares held in the original disclosures were correct, except that Mr Stuart McClure is not a director of Summer Vine Pty Ltd as disclosed in 1.

Mr. Kovac notes that while he is an executive, he is not a director of Indemitsu Lindfield Pty Ltd and the disposal and voting on the CMG shares that it holds is a matter for its board.

The relevant Directors have considered their respective holdings, and confirmed that the attached updated Appendix 3Xs are correct.

This oversight was unintentional and has now been rectified. The misclassifications in the original disclosures were self-identified by the Company in the process of completing the 2023 Annual Report.

The Company confirms that it is aware of its disclosure obligations and is compliant with the Listing Rules, particularly Listing Rules 3.19A and 3.19B, and is satisfied that its existing processes are adequate to meet its compliance obligations.
