**Notice under section 708A of the Corporations Act**

Dateline Resources Limited ACN 149 105 653 (ASX: DTR) (**Company**) hereby advises that a total of 1,202,500 fully paid ordinary shares in the Company (each, a **Share**) were issued by the Company to sophisticated and professional investors on 4 April 2023.
