ACTIVITY STATEMENT

Activity Report:

In connection with the Appendix 4C; Quarterly Cash Flow Report entities subject to listing rule 4.7B, the Directors are pleased to provide the Activity Statement for the quarter ending 31st December 2022.

Details on our business operations and activities are as described in the Annual Report released on 30th September 2022 and there is no new development other than what is disclosed in the Annual Report. Expenses incurred during the quarter include PT Energi Sengkang payment for gas purchases, power plant operation (the payable amount) and maintenance costs (for Indonesia), staff costs, business administration, site security costs, and where possible, preservation of assets on project development sites, in Philippines and Indonesia.

Within the Appendix 4C (item 6.1), the disclosed payment to related parties of USD2.248 million relates to payments to PT. CEPA for the O&M Contract for the Sengkang Power Plant.

On 24 November 2022, the Company announced a non-renounceable pro-rata entitlement offer to existing shareholder to EWC. The Offer closed at 22 December 2022, and raised approximately A\$23,306,265.10 for approximately 466,125,302 New Shares. In addition 46,612,593 New Options are also issued to shareholders who subscribed for their entitlement. Under the Offer, Energy World International Ltd, the entity related to Chairman Stewart Elliott, has taken up half of its \$19.0 million entitlement by way of reducing debt owed to it and the balance paid in cash.
