DXN Limited executes contract for the design, supply and delivery of a modular data centre contract with Stanmore SMC Pty Ltd for \$1.9m AUD.

Highlights:

- DXN has signed a contract with Stanmore SMC Pty Ltd (**SMC**) a wholly owned subsidiary of Stanmore Resources Limited (ASX: SMR) for the design, supply and install of a modular data centre (DXN Module)
- Deployment will be for the South Walker Creek mine in QLD to support its future operations and future technologies across its mine site.

Prefabricated modular data centre specialist, DXN Limited (DXN or the Company), is pleased to announce that it has entered into a contract to supply a prefabricated modular data centre for a total contract value of A\$1.9m with SMC.

DXN's CEO Shalini Lagrutta said "This project is a testament to the growth of Edge data centres requiring on-premises, on-site demand in the mining market segment where automation and local compute requirements continue to grow. SMC required a high-quality solution for their Edge data centre deployment and DXN is able to deliver this with our prefabricated modular data centre solutions. This deployment will be DXN's 45th prefabricated modular data centre to be built and deployed since FY20."

Prefabrication will commence in DXN's factory in Perth and the modular data centre is expected to be delivered by July 2024.
