



Amendment to Appendix 2A

Melbourne, Australia, 22 September 2023: dorsaVi (ASX: DVL) (**dorsaVi** or the **Company**) refers to the ASX Appendix 2A released on 10 May 2023 in relation to the issue and quotation of 11,132,849 ordinary shares. It has been identified that there was administrative error in that form. The form stated that all of the shares were issued under the Company's 15% placement capacity in Listing Rule 7.1. The form should have stated that 2,844,118 ordinary shares were issued under the Company's 15% placement capacity in Listing Rule 7.1 and 8,288,731 ordinary shares were issued under the Company's placement capacity in Listing Rule 7.1A, for which shareholder approval was obtained on 17 November 2022.
