On 18<sup>th</sup> May 2020 the maturity date was extended by 1 year to 7<sup>th</sup> December 2021. On 22<sup>nd</sup> July 2021 the maturity date was further extended to 1<sup>st</sup> July 2022. Subsequently, with an effective date of 22<sup>nd</sup> December 2021, the maturity date was further extended to 1<sup>st</sup> February 2023. On 4<sup>th</sup> November 2022 the maturity date was further extended to 1<sup>st</sup> February 2024.</p> <p>\$650,000 was raised through the issue of Unsecured Convertible Notes on 25<sup>th</sup> January 2018 to various note holders with an annual coupon of 10% payable quarterly in arrears. On 18<sup>th</sup> May 2020 the maturity date was extended by 1 year to 25<sup>th</sup> January 2022. The Unsecured Convertible Notes are subject to a subordination agreement and will therefore not be repaid prior to the Secured Convertible Notes.</p>
