8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

No. The Company has initiated fundraising via convertible debt to re-commence operations at its Yervas Buenas project selling the waste material accumulated from its mining operations. It has identified a highly qualified partner with some 20 years experience in rock processing, and dealing with cement companies, who are the primary customer base for this undertaking. Documentation of these arrangements is currently underway and operations are anticipated to commence within the coming weeks with sales shortly thereafter.

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Yes. The Company is currently raising funds via convertible debt and anticipates conducting a rights issue to meet its ongoing and future business objectives. The Company is working on the necessary steps to proceed with the convertible debt and the proposed rights issue.


Yes, subject to further raising of convertible debt and conducting the rights issue.
