This notice is given by Wright NomineeCo Pty Ltd ACN 665 965 266 (**Allegro BidCo**) for the purpose of section 630(3) of the *Corporations Act 2001* (Cth) (**Corporations Act**) in respect of its takeover offer (**Offer**) for all of the fully-paid ordinary shares in Slater & Gordon Limited ACN 097 297 400 (ASX:SGH) (**SGH**) contained in its bidder's statement dated 3 March 2023, as supplemented on 14 March 2023 (**Bidder's Statement**).

Capitalised terms in this notice have the same meaning given in the Bidder's Statement, unless the context requires otherwise.


In accordance with section 630(3) of the Corporations Act, Allegro BidCo gives notice that, as at the date of this notice:

- (b) Condition 2 of Annexure A of the Bidder's Statement (No Company Prescribed Occurrences Condition) has not been fulfilled or waived on the date this notice is given and none of the events stipulated in that condition, so far as the Bidder knows, have occurred and, accordingly, the Offer remains subject to that condition; and
- (c) based on Offer acceptances received to date, Allegro BidCo's voting power in SGH is 72.52%.

Allegro BidCo reserves its right to waive Condition 2 of Annexure A of the Bidder's Statement (No Company Prescribed Occurrences Condition) and extend the Offer Period where it is entitled to do so under the Corporations Act.
