## BlueScope Board appointments

BlueScope Chairman, Mr John Bevan, today announced the appointment of two new Directors to the BlueScope Board: Mr Peter Alexander who is based in the US and Ms Jane McAloon who is based in Melbourne.

“The Directors and I are very pleased to welcome Peter and Jane to the Board”, said BlueScope Chairman John Bevan. “They bring a breadth of experience that will give us greater insight into the building and construction industry in the US as well as broad Australian commercial experience in sectors relevant to BlueScope.”

Ms McAloon is an experienced non-executive director and Chair. Mr Alexander has considerable experience in leading companies in the building and construction industry and was previously a non-executive director of Boral Limited.

“In the last few years, the shape of the Company has changed such that in FY2022, the US made up more than half of BlueScope’s Underlying EBITDA, and our total investment in the US exceeds \$5 billion,” continued Mr Bevan. “These new appointments, following those of Ms K’Lynne Johnson and Mr ZhiQuiang (ZZ) Zhang earlier this year, ensure we have appropriate regional and sector Board representation to match the Company’s business profile and growth ambitions.”

Ms McAloon said: “BlueScope is at an exciting point in its strategic journey as major initiatives come to fruition both in Australia and globally, and I look forward to joining the Board and making a contribution to its future success.”

Mr Alexander said: “I believe my experience of US markets, particularly in the building and construction industry, and in managing large and complicated technology, retail and distribution global firms, will support BlueScope as it continues to deliver on its transform, grow, deliver strategy.”

The new appointments take effect from 30 September. Ms McAloon and Mr Alexander will nominate for election at the 2022 Annual General Meeting.

### Jane McAloon

Ms McAloon is Chair and a non-executive director of EnergyAustralia. She is a non-executive director of Newcrest Mining Ltd, United Malt Group Ltd, HMC Capital Ltd and Allianz Australia Ltd. Ms McAloon spent 9 years as Group Company Secretary at BHP Billiton, including two years on the Group Management Committee as President Governance. Prior to this, Ms McAloon was Group Manager, Regulatory & Public Affairs and Company Secretary at AGL Energy Ltd. Ms McAloon has worked in executive leadership roles with the NSW Government Cabinet Office and the Energy, Rail and Natural Resources Departments. Ms McAloon previously worked in private legal practice and is a former non-executive director of several listed companies. Ms McAloon is Chair of the Monash University Foundation, an independent member of the advisory board of Allens and a senior adviser to Brunswick Group Asia.

### Peter Alexander

Mr Alexander is a former non-executive director of Boral Limited. Mr Alexander is an experienced former chief executive with more than 28 years of senior executive experience in US building materials and distribution, technology products and services. From 2010 until 2018, Mr Alexander was CEO of Building Materials Holding Corporation and then President and CEO of the merged NASDAQ listed group BMC Stock Holdings Inc (BMC), a building materials distributor and construction solutions provider. Prior to this, Mr Alexander was President and CEO of ORCO Construction Distribution from 2005 to 2009, the largest independent building materials distributor in the Western United States. He was managing partner of KinderOaks Business Services from 2002 to 2005. Mr Alexander previously served as President and CEO, or in other executive positions, for companies in the technology, retail, distribution and service industries, including GE Capital, ComputerLand/Vanstar, Premiere Global Services and Coast to Coast Hardware. Mr Alexander is based in North America.
