ISSUE OF SHARES TO DIRECTORS IN LIEU OF CASH REMUNERATION AND SECTION 708A(5)(e) NOTICE

SECOS Group Limited (“SECOS” or “the Company”) has issued **203,718** fully paid ordinary shares under Loan Share Plan to two of its directors- M/s Richard Tegoni and Donald Haller Jr., in lieu of the part payment of their respective remuneration for the quarter ending 30 September 2017.

M/s.Tegoni and Haller each had agreed to accept 50% of their respective **September 2017** quarter remuneration to be paid in Shares.

The issue of these shares to Directors was approved by shareholders at the Annual General Meeting held on 18 November 2016 (Resolutions 7 & 9). The shares are issued at an issue price of \$0.080/share. The share issue price has been determined based on volume weighted average sale price of SECOS shares for September 2017 Quarter.

In respect of the issue of shares, the Company gives notice under section 708A (5)(e) of the Corporations Act that;

The abovementioned shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;

The Company also states, that as at the date of this notice:
