## **Results of Extraordinary General Meeting**

Bellamy's Australia Limited (ASX: BAL) (Bellamy's) has today held an extraordinary general meeting of its shareholders for the purposes of considering resolutions requisitioned by shareholder, Black Prince Private Foundation.

Voting on all resolutions was conducted by poll. The results of the poll were:

- **Resolution 1a** – Election of Director – Jan Cameron – not carried
- **Resolution 1b** – Election of Director – Chan Wai-Chan – carried
- **Resolution 1d** – Election of Director – Rodd Peters – carried
- **Resolution 2** – Removal of existing Director – Patria Mann – not carried
- **Resolution 4** – Removal of existing Director – Michael Wadley – carried
- **Resolution 5** – Removal of existing Director – Charles Sitch – carried
- **Resolution 6** – Removal of additional Director/s – carried

Resolution 1c related to the election of Vaughan Webber as a Director of Bellamy's and was not put to the meeting after Mr Webber withdrew his nomination.

Resolution 3 related to the removal of existing Director, Launa Inman, from the Board and was not put to the meeting after Ms Inman resigned as a Director of the Company at the meeting.

Chan Wai-Chan and Rodd Peters have each been elected as Directors of Bellamy's with immediate effect.

Michael Wadley and Charles Sitch have each been removed as Directors of Bellamy's with immediate effect.
