### **NEW SHARES ISSUED TO CONVERTIBLE NOTES HOLDER AND SECTION 708A(5)(E) NOTICE**

SECOS Group Limited ("SECOS" or "the Company") has issued **7,175,092** fully paid ordinary shares ("Shares") to a convertible note holder on 31 January 2018 pursuant to Convertible Notes Deed entered into on 22 December 2016.

The issue of the Shares was approved by shareholders at the Annual General Meeting held on 30 November 2017 (Resolution 4). The shares are issued at an issue price of \$0.090/share. The share issue price was based on volume weighted average selling price of SECOS shares 10 days before notice of conversion was given.

In respect of the issue of shares, the Company gives notice pursuant to section 708A(6) of the *Corporations Act 2001* (Cth) ("Corporations Act") that:

- (a) the Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- (b) this notice is given under section 708(5)(e) of the Corporations Act;
- (c) as at the date of this notice, the Company has complied with:
  - i) the provisions of Chapter 2M Corporations Act as they apply to the Company; and
  - ii) section 674 of the Corporations Act; and
- (d) as at the date of this notice, the Company is not aware of any 'excluded information' within the meaning of sections 708A(7) and 708A(8) of the Corporations Act to be disclosed under section 708A(6)(e) of the Corporations Act.
