ISSUE OF SHARES TO DIRECTORS IN LIEU OF CASH REMUNERATION AND SECTION 708A(5)(e) NOTICE

SECOS Group Limited ("SECOS" or "the Company") has issued **201,169** fully paid ordinary shares to two of its directors, Mr Richard Tegoni and Mr Donald Haller Jr., in lieu of the part payment of their respective remuneration for the quarter ending 31 December 2017.

Mr Tegoni and Mr Haller each had agreed to accept part of their respective quarterly remuneration to be paid in Shares.

The issue of these shares to Directors was approved by shareholders at the Annual General Meeting held on 30 November 2017 (Resolutions 10 & 11). The shares are issued at an issue price of \$0.080/share. The share issue price was based on volume weighted average selling price of SECOS shares for December 2017 Quarter.

In respect of the issue of shares, the Company gives notice under section 708A (5)(e) of the Corporations Act that;

The abovementioned shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;

The Company also states, that as at the date of this notice:
