Market Update - Shareholder Claimant Scheme- Correction to earlier notice

Slater and Gordon Limited (ASX: SGH) (the “**Company**”) refers to its announcement on 15 December 2017 that its two inter-conditional creditors’ schemes of arrangement were approved by the Federal Court of Australia and are now effective.

Terms used in this announcement are as defined in the Shareholder Claimant Scheme Explanatory Statement released on 30 October 2017.

Shareholder Claimants now have until 30 January 2018 to lodge a proof of debt form with Mark Korda and Bryan Webster of KordaMentha, who have been appointed as Scheme Administrators. Shareholder Claimants who do not lodge a proof of debt form by 30 January 2018 will not be entitled to share in a distribution from the Scheme Fund. Whether a Shareholder Claimant receives a distribution, and the amount of any distribution, will depend upon the Scheme Administrators adjudication of their proof of debt form. In the announcement dated 18 December 2017 this deadline was incorrectly stated as 30 January 2017.

The proof of debt form must contain the particulars of the Shareholder Claim and satisfactory evidence of the face value of the Shareholder Claim.

Maurice Blackburn will be lodging proof of debt forms for all registered group members of the proceeding commenced against the Company by Matthew Hall (“**Hall Proceeding**”). Other Shareholder Claimants can lodge proof of debt forms individually or, if they are group members of the proceeding commenced against the Company by Babscay Pty Ltd or the potential claim notified to the Company by Robert Delaney, talk to their lawyers about whether they will lodge a proof of debt form on their behalf. The Company notes that Shareholder Claimants (other than Hall Proceeding group members) do not need to engage a lawyer to lodge proof of debt forms.
