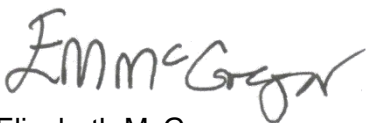
**Appendix 3Y – Mr Russell Yardley**

I refer to the attached Appendix 3Y, in respect of two changes of a director's relevant interests which occurred on 14 November 2019 and 26 November 2019. Under Listing Rule 3.19A.2, the change of interests which occurred on 14 November 2019 should have been notified to ASX by 21 November 2019. The late notification was caused by an administrative oversight.
