ISSUE OF PLACEMENT SHARES AND OPIONS - SECTION 708A(5)(e) NOTICE

SECOS Group Limited ("SECOS" or "the Company") has issued **31,785,750** fully paid ordinary shares (**Shares**) at issue price of \$0.04 (4 cents) per share together with 15,892,875 unlisted options to acquire fully paid ordinary shares (**Options**) with an exercise price of \$0.06 (6 cents) expiring on 16 May 2021. Shares and Options were issued to sophisticated investors under the placement announced to the market on 2 May 2019 (**Placement**) pursuant to the Company's placement capacity under Listing Rule 7.1.

Directors of SECOS have applied for 8,071,500 shares and 4,035,750 unlisted options on the same terms as the Placement. The issue of Shares and Options to Directors is subject to shareholder approval in next Annual General Meeting.

The Placement raised \$1,594,290 further strengthening the Company's ability to execute its business plan in a growth market the Company is experiencing.

In respect of the issue of shares, the Company gives notice under section 708A (5)(e) of the Corporations Act that:

The abovementioned shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act.

The Company also states, that as at the date of this notice:

- it has complied with the provisions of Chapter 2M Corporations Act as they apply to the Company; and section 674 Corporations Act; and
- it is not aware of any excluded information within the meaning of Sections 708A(7) and 708A(8) of the Corporations Act.
