NEW SHARES ISSUED AND SECTION 708A(5)(E) NOTICE - amended

SECOS Group Limited ("SECOS" or "the Company") has issued **13,075,808** fully paid ordinary shares ("Shares") on 19 December 2018.

The issue of the Shares was approved by shareholders at the Annual General Meeting held on 30 November 2018. 9,681,776 shares were issued at an issue price of \$0.062/share (Resolution 7, 8, 10, 11) and 2,741,919 shares were issued at \$0.11/share (Resolution 14, 15, 16, 17). Included in the issue, 652,113 fully paid ordinary shares at \$0.062/share were issued in lieu of consulting fees.

In respect of the issue of shares, the Company gives notice pursuant to section 708A(6) of the *Corporations Act 2001* (Cth) ("Corporations Act") that:

- (a) the Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- (b) this notice is given under section 708(5)(e) of the Corporations Act;
