The number of shares was calculated using the closing share price of the Company's shares listed on the ASX on 17 July 2020 (\$0.028) when the proposal to issue Shares to Dr Ronchi in lieu of a reduction in cash and other entitlements owing to him was agreed by the Board to be put to shareholders for approval. Shareholder approval was granted on 27 November 2020 for 2,707,286 ordinary shares to be issued to Dr Ronchi in lieu of a reduction in cash and other entitlements owing to him.
