## Company Update

Australian Internet of Things (IoT) and healthcare technology company, Xped Limited (ASX:XPE) (“Xped” or the “Company”) is pleased to provide this market update regarding further progress and developments.

### Healthcare Business

JCT Healthcare (“JCT”), a wholly owned subsidiary of the Company, is a provider of innovative technology solutions for the healthcare sector. JCT Healthcare develops and distributes its own range of nurse call hardware and software solutions for use across multiple healthcare sectors including hospitals, aged care, disability care and supported independent living.

JCT has made a significant step forward in its validation of a branded “Smart Technology Pack” specifically designed for the growing Independent Living sector. Utilizing traditional and proven JCT Technology, JCT continues its focus on this emerging market with a saleable solution expected to be complete by Q3 2021. This product is designed to complement and expand its existing range of JCT Solutions.

JCT Healthcare has recently completed several Nurse Call upgrades to notable Private Hospitals and Aged Care Facilities in metropolitan Adelaide, Regional NSW and the NT.

A relaxing of COVID-19 restrictions and increased operational activities has assisted JCT in the completion of its projects.

The long-term outlook for JCT’s business is strong with several projects nearing completion and pending projects awaiting commencement. Sales in services related products such as Support & Maintenance have increased reoccurring revenue and remains a key focus of the Sales Team.

The Business Development & Marketing strategy has an emphasis on strengthening client relationships, increasing JCT’s Support and Maintenance offerings and building upon the product suite to enhance JCT’s market presence.

## Legacy Issues

There has been no change since the last quarter. The final step in the remediation process for the Penola geothermal well is due to be completed in the coming quarters once we resume work due to the impact of COVID 19. Once completed, a \$100,000 security bond will be returned to the Company.

## Business Development and Others

As announced on 2 January 2020, the Company completed a A\$250,000 share placement ("Placement Agreement") with Teko International Limited (Teko). The Company has had ongoing discussions with Teko in respect to a potential claim asserted by Teko against the Company for allegedly misrepresenting the Company's unrecorded liabilities, including the Heuresy liability payment, by its then directors. Teko also has assert that the Company has not performed its obligation to call for a shareholders meeting to approve the issuance of a 250,000 options at an exercise price of A\$0.001 exercisable any time up to and including 30 June 2020 which the Company has addressed at the Annual General Meeting today. The Board believes that there may be some exposure to the Company in respect to the representations made by the then Board members and the issuance of the options. If the Company were to be subject to legal action that could be taken by Teko, there could be no assurance as to the outcome or the costs required to defend any such action. The Company will continue to discuss the issue with our legal advisors and negotiate with Teko to seek the most desirable outcome for the Company and its shareholders.
