## **Non-Renounceable Entitlement Offer - Update**

**Christchurch, New Zealand, 28 August 2020**

The Board of Powerhouse Ventures Limited (**PVL** or the **Company**) is pleased to update shareholders with respect to the allocation and issue of the shortfall shares and shortfall options available under the non-renounceable entitlement offer (the **Entitlement Offer**) announced on 17 July 2020 and that closed on 6 August 2020.

In summary, the Company has issued:

1. 2,000,000 shortfall shares and 2,000,000 attaching options (\$A0.07, 31 December 2023) to PVL Director Russell Yardley, after obtaining shareholder approval on 27 August 2020, raising \$100,000;
2. 2,000,000 shortfall shares and 2,000,000 attaching options (\$A0.07, 31 December 2023) to PVL Director Geoff Gander, after obtaining shareholder approval on 27 August 2020, raising a further \$100,000; and
3. 16,000,000 shortfall shares and 16,000,000 attaching options (\$A0.07, 31 December 2023) to clients of PAC Partners Securities Pty Ltd (**PAC Partners**), raising a further \$800,000.

On the basis of the above, and including the 9,694,426 shares and attaching options issued on 13 August 2020, PVL has now issued a total of 29,694,426 shares and attaching options under the Entitlement Offer and Shortfall Offer for a total raising of \$A1,484,721 before costs.

PAC Partners has charged a placement fee of 6% meaning net proceeds from the PAC Partners placement is \$A752,000.

The PVL Board will provide an update on the listing of the options in due course.
