1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

The Company has commissioned two new nitrile glove production lines in June 2020 that will increase production and sales in future quarters; therefore the net operating positive cashflow from increased sales is expected to improve the Company's operating cash inflows and meet future operating cash outflows.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

The Company has entered into an agreement for the sale of its land and factory buildings for MYR29M (AUD\$9.7M) and subsequent leaseback of the said land and buildings, that is due to be completed in August 2020 and will generate capital inflow to the Company to be used for working capital, repayment of debt and future glove line expansion purposes.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

YES – based upon increase nitrile glove production and sales, and capital inflow from the sale of land and buildings as reported above in points 1 and 2 respectively.
