### **Results of Meeting**

In accordance with ASX Listing Rule 3.13.2 & section 251AA of the Corporations Act, the following information is provided to the ASX in relation to the resolutions passed by the shareholders of Candy Club Holdings Limited (“Company”) at its Annual General Meeting of shareholders held on 30 May 2022.

All resolutions were put to the meeting by a poll, called by the Chair pursuant to the Notice of Meeting. The Chair voted all undirected proxies held at their discretion in favour of each resolution. A summary of the voting results is set out on the following page.

As more than 25% of votes were cast against Resolution 1 - Adoption of Remuneration this constitutes a first strike for the purposes of the Corporations Act.
