



## Option expiry notice – expiring 30 June 2017

Atlas Iron Limited (**Atlas**) (ASX: AGO) advises that it has been granted a waiver from ASX Listing Rule 6.24 to the extent necessary to permit Atlas to not send notices required by paragraph 6.1 of Appendix 6A in relation to the 1,744,762,043 quoted options that it issued under its prospectus dated 11 June 2015 and which are exercisable at \$0.075 each, expiring on 30 June 2017 (**Prospectus Options**).

In accordance with the ASX Listing Rules and the conditions of the waiver granted by ASX, Atlas provides the following information:

1. The number of options to which this notice applies is 1,744,762,043.
2. On exercise, each option entitles the holder to receive 1 fully paid ordinary share in Atlas. If all options were exercised, 1,744,762,043 fully paid ordinary shares would be issued.
3. The exercise price for each option is \$0.075.
4. The due date for payment of the exercise price is 5:00pm (Perth time) on 30 June 2017.
5. If payment is not received by 5:00pm (Perth time) on 30 June 2017, the options will lapse and all rights under the options will cease.
6. Official quotation of the options by ASX will cease on 26 June 2017.
7. The market price of fully paid ordinary shares in Atlas on 30 May 2017 (being the last trading day prior to the date of this notice) was **\$0.014**.
8. During the three months immediately preceding the date of this notice, the highest market price of fully paid ordinary shares in Atlas was **\$0.037** on **3 March 2017**, and the lowest market price was **\$0.012** on **8 May 2017**.
