## PHARMAUST RAISES A FURTHER \$534k

PharmAust Limited ("PharmAust") (ASX: PAA) has issued a further 10,674,650 fully paid ordinary shares and 1:3 attaching options (exercise price \$0.12, expiry 31 November 2019) in the final tranche of securities under the Company's Rights Issue raising \$534k. The total raised to date under the Rights Issue is \$3.24m.

The shortfall shares have been issued pursuant to the Rights Issue Prospectus dated 7 November 2016, in which the Company reserved the right to place any shortfall securities within 3 months from the closing date of the Rights Issue.
