Share Placement Completed

Aruma Resources Limited (ASX: AAJ) is pleased to advise that it has completed a placement of 50,000,000 fully paid ordinary shares at a price of 2 cents per share (Placement) to raise \$1,000,000 to sophisticated and professional investors. The Placement (announced 1 March 2018) was completed with the support of State One Equities with the funds raised to be used for targeted exploration programs on the Company's advanced Slate Dam and Beowulf gold projects near Kalgoorlie as well as costs of the Placement and general working capital.

Section 708A Notice

The shares issued are part of a class of securities quoted on the ASX Limited. The Company gives this notice pursuant to Section 708A(5)(e) of the Corporations Act.

The securities are issued without disclosure to investors under Part 6D.2, in reliance on Section 708A(5) of the Corporations Act. The Company, as at the date of this notice, has complied with:

the provisions of Chapter 2M of the Corporations Act; and

Section 674 and 675 of the Corporations Act.

There is no excluded information for the purposes of Sections 708A(7) and (8) of the Corporations Act.

Information Required Under Listing Rule 3.10.5A

The Placement shares were issued pursuant to ASX listing rules 7.1 (10 million shares) and 7.1A (40 million shares). Aruma Resources provides the following information as required under ASX listing rule 3.10.5A:

- a) The dilution to existing shareholders at the time of the Placement as a result of the issue under ASX listing rule 7.1A was 8.05%.

Details of the approximate percentage of the issued capital post the Placement of shares under ASX listing rule 7.1A held by the pre-Placement shareholders and new shareholders are:

Pre-Placement shareholders who did not participate in the Placement	91.95%
Pre-Placement shareholders who did participate	1.36%
Participants in the Placement who were not previously shareholders	6.69%

- b) Aruma Resources issued shares to sophisticated and professional investors as it was considered to be a more efficient mechanism for raising the funds for this Placement. The Placement did not expose the Company to the market volatility that it may have experienced over a more extended capital raising process such as a pro-rata issue;
- c) No underwriting arrangements were in place for the Placement; and
- d) The capital raising fees payable to the brokers to the Placement are 6% of the total funds raised and the issue of 4 million unlisted options exercisable at 4 cents each expiring 2 March 2020.
