SHARE PURCHASE PLAN CLOSES OVERSUBSCRIBED

The Directors of Cullen Resources Limited are pleased to announce that the Share Purchase Plan ("SPP") which closed on 17 November 2017, was well supported by shareholders and oversubscribed. The issue of shares under the SPP was on a "first come first serve basis" so all applications received from shareholders up to and including 16 November will receive their full allocation. All applications received on 17 November 2017, will each be allocated \$1,000 worth of shares, and the balance of their monies received will be refunded.
