### HELIO TRANSACTION

On 21 September 2017, Nickelore Limited (ASX: NIO) (**Nickelore** or the **Company**) announced that the transaction to acquire 100% of the issued capital of Helio Energia Holdings S.A. (**Helio**), would not proceed as Helio advised the Company that it had changed strategy and would not proceed with the transaction.

The Company will now evaluate its position and will need to satisfy the ASX requirements of Listing Rule 12.1 prior to re-quotation. Nickelore will also be evaluating a number of other opportunities.

### CANEGRASS PROJECT

Nickelore continued to fund its obligations in respect to the Canegrass Project during the quarter.

### FINANCIAL

At 30 September 2017 Nickelore held \$132,000 in cash reserves.
