APPENDIX 3B – ISSUE OF SHARES

Raven Energy Limited (ASX: REL) (**Raven** or **Company**) is pleased to announce that it has agreed to issue 555,555,555 ordinary fully paid shares in the Company at an issue price of A\$0.0018 per share to Bombora Natural Energy Pty Ltd as part of the Company's acquisition of Bombora's 40% shareholding in Gasfields LLC, a limited liability company incorporated in California, 60% of which is currently owned by the Company (**Acquisition**). Bombora is a wholly owned subsidiary of ASX listed Pancontinental Oil and Gas Limited (**Pancontinental**) (ASX:PCL). As a result of the Acquisition, Gasfields will be a wholly owned subsidiary of the Company.

The issue of shares will satisfy the share consideration element of the Acquisition.

Importantly, as per the Sale and Purchase Agreement entered into by the parties, the shares will be voluntary escrowed for a period of twelve (12) months from the date of issue and will be cleansed for secondary trading upon release in August 2019.

For further details of the Acquisition, refer to the Company's announcement dated 5 July 2018.
