

ASX Announcement
17 May 2019**Capital Raising Update**

On 3 April 2019, AustSino Resources Group (**ASX: ANS** or **Company**) announced that the Company had entered into a share placement agreement with Mr Ma Kai Hui, a sophisticated investor who is a citizen of the People's Republic of China.

Mr Ma agreed to purchase 134,938,590 fully paid ordinary shares at a price per share of AUD 0.013 (1.3 cents) for a total purchase price of approximately AUD 1.75 Million.

The Company confirms that the necessary funds have now been received into the Company's Australian bank account. Accordingly, the Company has issued the shares to Mr Ma.

The shares are being issued under the Company's existing capacity afforded under Listing Rule 7.1. The shares will remain in escrow until the earlier of 12 months from the date of issue or until the Company issues a prospectus, cleansing statement or some other form of disclosure document.

The issue of these shares are reflected in the attached Appendix 3B.
