**CLEANSING NOTICE  
NOTIFICATION UNDER SECTION 708A(5)(E)**

On 12<sup>th</sup> of July 2019 NTM Gold Ltd (“**NTM**” or “the **Company**”) issued 100,000,000 fully paid ordinary shares (the **Shares**). These Shares were included in the announcement to Australian Stock Exchange (“ASX”) on 8<sup>th</sup> July 2019 and an Appendix 3B announcement to the ASX on 11<sup>th</sup> of July 2019.

The Company gives notice pursuant to Section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**) that:

    - the rights and liabilities attaching to the Shares.
