
CLEANSING NOTICE
NOTIFICATION UNDER SECTION 708A(5)(E)

On 13 March 2019 NTM Gold Ltd ("**NTM**" or "the **Company**") issued 37,500,000 fully paid ordinary shares (the **Shares**) to DGO Gold Limited. These Shares were included in an Appendix 3B announcement to the Australian Stock Exchange ("ASX") lodged on 14th of March 2019.
