The Board of Syngas Limited ("Syngas" or "Company") hereby presents the March 2019 Quarterly Report.

Corporate Transaction and Future Direction

During the quarter the Board continued to evaluate and explore proposals for restructuring and acquisition of assets which would enable the Company to comply with Chapters 1 and 2 of the ASX Listing Rules. The Company will make the necessary announcement when a more definitive proposal is finalised and after consultation with the ASX.

Finance

During the Quarter the Company continued to rely on the loan facility provided by Mr Low Siak Wei, a director of the Company, which as at 31 March 2019 was drawn down to the amount of A\$700,000. In addition, the Company also has 2 unsecured loan facilities with AsiaPacific Businesslink Sdn Bhd, a company related to Mr Low Siak Wei totalling A\$750,000. As at 31 March 2019, the total amount drawn down from the loan facilities was A\$350,000.

- Unsecured loan facility of \$400,000 from AsiaPacific Businesslink Sdn Bhd, entity related to Director, Mr Low Siak Wei, which carries an interest rate of 9.25% per annum which has not been drawn down as yet. Loan facility expires 12 months from the date of the draw down. Loan facility matures 27 July 2019.

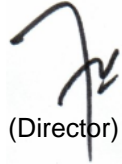
